PURPOSE/ EXECUTIVE SUMMARY

For the Committee to give further consideration to the composition of the Community Reference Group (CRG) following Council's deferral of this matter.

BACKGROUND

At its meeting held on 18 December 2007, Council resolved:

"that in accordance with clause 58(a) of the Standing Orders Local Law 2005 Council DEFERS the appointment of the Community Reference Group for the Ocean Reef Marina and REFERS the matter back to the Ocean Reef Marina Committee for further consideration."

Prior to the deferral of this matter at that Council meeting, the following motions and amendments were moved and seconded but not voted on:

Background information provided to the ORM Committee

The following background information to the CRG was submitted to the Ocean Reef Marina Committee at its meeting held on 12 December 2007:

- The City commissioned a consultancy firm called Gryphon to prepare a Community Participation Plan (CPP).
- Gryphon prepared this plan which recommended the establishment of a Community Reference Group (CRG) containing 30 people with membership broken down as follows:

- The Plan noted that "in the event that there are more individuals willing to serve on the CRG than there are places available, the final make up of the group will be decided by randomised selection".
- The CPP was developed having regard to the City's Public Participation Strategy which was adopted by Council.
- This Strategy includes a section headed 'How all sectors and groups can have the opportunity to participate'. Under this heading, it is stated:

"Participation targets may be achieved through:

- Random selection of residents from the City's databases with a personalised invitation to participate.
- Identifying and contacting individuals and groups with a special interest in the issue and inviting their participation.
- Advertising through public notices for expressions of interest in community newspapers to the wider community.
- Design, delivery and targeting of community education programs which are effective in empowering stakeholders to participate.

However representation on an issue is determined, the decision should be made public in the interests of good governance".

- The Strategy also includes a section on the public participation process where it
 is stated that "activities in this phase include ... identification of process for
 achievement of participation targets for the project, eg random selection, direct
 mail, displays at local venues".
- The CPP was presented to Council on 24 April 2007. Rather than endorsing the CPP, Council resolved to:
 - "1 Note the Gryphon report and the proposed CPP.
 - 2 Establish a CRG to a maximum of 30 people.
 - 3 Support the proposed role for the CRG as outlined on page 9 of the Gryphon report."

Council also resolved to establish the ORM at this meeting. Here it is important to note that the CPP was noted but not endorsed by Council. The only relevant decision for the purposes of this report is that the CRG would have a maximum of 30 people.

 A meeting of the ORM was held on 17 July. At this meeting a report was presented entitled 'Commencing the Ocean Reef Consultation Process'. This report stated:

"The Ocean Reef Marina Committee's first task will be to identify those people who should be appointed to the Community Reference Group. This consideration will be based on the expressions of interest received. The actual appointment of members to the Community Reference Group will be made by Council as the Committee has no delegated authority".

- Here it is important to note that the report mentions the Group's composition being based on the expressions of interest received. City Officers took this to mean that only people who expressed an interest would be considered.
- Because the report 'Commencing the Ocean Reef Consultation Process' was not highly detailed and specific, the Officer's recommendation was that the Committee note the report. However, the Committee resolved to:
 - "1 Endorse the community participation approach outlined in this report (i.e the paragraph quoted above), and;
 - Note that Council will determine and endorse the final composition of the Community Reference Group."
- The ORM met again on 12 December to consider a report in relation to the public feedback received.
- This report presented the expressions of interest in accordance with the four categories identified in the CPP (which had only been noted by Council). It is for this reason that the report to the Committee on 12 December stated "The original report on the consultation process proposed a CRG of 30 people drawn from the four categories in the following manner Further, in the event that more individuals were willing to serve on the CRG than there were places available, the final make up of the group was to be decided by randomised selection".

Here it is important to note the use of the word 'was' in the final sentence above. Random selection was proposed in the CPP. However, this was not endorsed by Council and no replacement system was identified.

- As a result of the fact that Council had made no decision in relation to the selection of members, the final paragraph of the comment section gave two options for selection: either "to assess each applicant's submission while the other is through random selection".
- The final sentence under the comment section noted "Here it should be noted that the City's Community Consultation Plan suggests random selection as an appropriate method to use in certain cases".
- This sentence was kept deliberately vague as the Public Participation Strategy does not deal with this situation directly. However it does mention random selection in a range of places while there is no mention of selection on merit.

DETAILS

A total of 132 Expressions of Interest were received for membership of the CRG. Of the four categories of membership identified, the following lists the number of applications in each category.

A summary of the EOIs received is provided in Attachment 1 to this report. The actual applications are provided in the Councillor's Reading Room and copies have been made for members of the ORM Committee.

At the ORM Committee meeting of 12 December 2007, seven submissions were discovered at the last moment which were presented on the night. Having considered these in more detail subsequent to the meeting, each had been excluded deliberately for the following reasons.

	M Scundrett	He indicated he was representing both himself and a company 'Aquasports Boat Hire'. He indicated an address of Glen Forest, outside of the North West Corridor and was subsequently excluded.

^{*} It should be noted that the Committee selected Mr S Bray as a representative of Category B. It should also be noted that Mr Bray's application indicated that he was a resident of both Ocean Reef and Iluka, together with the fact that he indicated "I regret that due to travel commitments and other work commitments I am unable to participate as much as I would like, ie. I am unable to attend meetings in Perth at this time."

An application was also received on 4 October 2007, six days after the closing date, from a Mr George Shaw. Mr Shaw indicated he sought membership under Category A as he is a resident of Ocean Reef.

COMMENT

In reconsidering the CRG's composition the Committee needs to make a number of decisions.

1 Should applicants be selected randomly or on merit?

As indicated in the background section to this report, no definitive position can be gauged from past decisions of Council on which approach to use. It is noted that at its 12 December 2007 meeting, the Committee chose the merit option.

2 Should the CRG's composition be expanded beyond 30?

Here it should be noted that Council previously made the decision (24 April 2007) that the group contain a maximum of 30 people. Any extension would require this decision to be amended.

3 Should five people be chosen from the broader north west corridor community?

The CPP recommended five people be drawn from the broader north west corridor although this position was never endorsed by Council.

4 Should more than five positions be allocated to community groups/agencies?

The CPP recommended that five people be drawn from this category although this was never endorsed by Council.

5 How should late applications, applications which provided no reason for membership and applications from outside of the north west corridor be dealt with?

Applicants in these categories were originally excluded because they were either submitted outside of the timeline, provided no rationale for involvement or were outside the participation area envisaged in the CPP.

6 How should the application from Mr S Bray be dealt with?

Mr Bray nominated under Category B but then stated "I regret that due to travel commitments and other work commitments I am unable to participate as much as I would like, i.e. I am unable to attend meetings in Perth at this time". Mr Bray was not included in the original list of applicants because of this statement. His application was identified in the last minute cross-check of applications and presented to the Committee on the night. The Committee selected Mr Bray as a Category B member.

PURPOSE / EXECUTIVE SUMMARY


To provide the Committee with the meetings notes of the Ocean Reef Marina Steering Committee.

BACKGROUND

At the meeting of 24 April 2007, Council agreed to the establishment of a Steering Committee, comprising the Chief Executive Officer, representatives of the Western Australian Planning Commission, Department of Planning and Infrastructure, LandCorp and the Water Corporation, to oversee the day-to-day activities of the Project Group.

The Project Group was established to manage the project, and consists of City officers, State Government Departmental representatives and relevant consultants. The Coffey Group (formerly Clifton Coney Group) has been appointed as the external Project Manager for this project, in accordance with their contract with the City.

The reporting structure of the project is:



On 17 December 2007 background documentation was circulated to Elected Members, particularly in relation to past decisions of the Ocean Reef Marina Committee and the Council, as well as clarification of the Terms of Reference of the Committee, the public participation process and recent past decisions of the Council in relation to the project.

Hello Mr Pickard.

I have recently viewed the City's Ocean Reef Marina Commitee's recomendations for the Community Reference Grooup members and i wish to register my dissapointment at what appears to be a total lack of representatives from the surfing comminity who stand to loose at least three surf breaks as a result of this development. A number of surfers myself included submitted detailed replies to the questions asked, we all suggested that we did not want to oppose the development but that we would not accept the loss of surf breaks at the entrance of the harbour and the possible destruction of the Mullaloo Point break due to sand movement caused by the development. We suggested a study to guarentee that Mullaloo Point not be damaged and that we be compensated with a replacement surf break north of the development as a replacement for those lost on the northern side. The suggestion was that this could be in the form of a re-modeled reef which could take place at the same time of construction and reef dredging. A quality surf break in close proximity of the development would also have obvious benefit to the development. The Mullaloo region has a large and committed surfing population, Mullaloo Point in season (May-Nov) is one of the best waves in Perth and the Mozzies reef breaks just north of the harbour entrance offers protection from onshore winds and is surfable in large swells when the rest of the coast is too big. These are natural assests that cost the City nothing to maintain, are used by surfers of all ages(including many rate payers). Many of the youth of the area stand to loose their natural sporting facility, a great number being too young to drive to other areas, the city could hardly say that they are interested in the youth of the area if you destroy their playgrounds. Imagine the outcry if football, cricket and netball facilities were bulldozed.

It is dissapointing that one suggestion by a councillor for a member of the surfing community mr R Tillbrook was rejected yet there seems to be plenty of representation from Recfishwa, Boating WA, Ocean Reef Surf Sports Club and Ocean Reef progress Association, but nobody it appears from surfing. A sceptic would say that boaties get what they want but surfers are not worth even thinking about. I hope the City of Joondalup do not think this way, because surfers are also businessmen, professionals, voters, ratepayers, dedicated mum's and dads and future leaders.

I also wish you to note that the metro coast does not have enough surf breaks to accomodate a large surfing population, and a potential loss of surf breaks will lead to even more dangerous overcrowding of other surf breaks. Many of us have looked at reef set ups along the Marmion Marine Reserve and thought a little rearanging of some reefs would create surfable waves, but we also accepted that this would never happen as they are in a marine reserve and reshaping the reef would be environmentally reckless. So why is that development of the Ocean Reef Marina with possible damage to the existing reef is even being considered?

I accept that those nominated are recomendations only, but it is very dissapointing that surfers views and dees appear to be ignored. I would be appreciate a reply, and i also offer my apologies if i have been inaccurate with some comments.

3. REPORTS

3.1 ROLE OF THE STEERING GROUP

As listed in the Council Report (CJ077-04/07) – 24 April 2007 – Page 93:

A Steering Committee, chaired by the Chief Executive Officer, which would comprise the Project Manager and representatives from the Western Australian Planning Commission, Department of Planning and Infrastructure, Landcorp and the Water Corporation. This would provide information and reports on matters requiring Council decision.

The attendees spoke on their understanding of the project.

- Landcorp to assist with the development site. Internal discussions had not commenced. The role of Landcorp will be confirmed with its Chief Executive Officer.
- Department for Planning and Infrastructure has provided a grant of \$700,000. Extent of authority is not known at this stage. Sandra McLeish will be responsible for the structure plan approvals process. Neil Foley from the Department has had past discussions on the project.
- Water Corporation has two areas of land within the project site. Corporation does not wish for project to affect its core business. The groyne area is vested crown land that could be transferred to the City (which needs to be finalised). Approximately \$130,000 of 'clean up' works was conducted in the late 1990s to enable handover. The inland pipes on the site could be used for services for boats, carpark etc.
- City of Joondalup Clayton Higham confirmed the funds from the abovementioned grant are to be expended on a structure plan exercise.
- City of Joondalup Bart Boelen confirmed that the Minister for Planning and Infrastructure had previously requested the involvement of Landcorp. As Landcorp is now required to operate on a commercial basis their involvement would need to be clarified, in particular their development rights (first right of refusal) and participation on the steering committee. The Water Corporation services of (pipes, easements etc) would be retained as infrastructure land.

3.2 PROJECT BACKGROUND

Clayton Higham advised that several attempts at progressing the project had occurred. Exercises had been conducted at the Ocean Reef Sea Sports Club with stakeholders looking at constraints and opportunities of the project. Expectations were sourced from community members of what will or won't occur.

A Structure Plan is to be prepared with Clayton Higham being responsible to assess the plan from the City's point of view, and Sandra McLeish (in the short-term) and Neil Foley (in the long-term) to be responsible for the approval of the plan.

Sandra McLeish advised that the impetitious for the structure plan was from sporting groups, use of boat ramp and City owned land.

Council purchased 24.4 ha piece of land at Ocean Reef adjacent to the boat launching facilities in 1979 as an investment for the benefit of the community, to enable the development of a range of recreational, commercial and ancillary service uses.

Details on preliminary plans and site assessments were discussed, including environmental considerations previously raised by the then Department of Environmental Protection. Sandra McLeish advised that 6 / 7 sketches were developed following consultation with the community and government agency technical officers. These were taken away to consolidate into the top three 3 ideas.

Garry Hunt advised that past information should be used as a reference point rather than a starting point.

Bart Boelen advised that the Department for Planning and Infrastructure published the Perth Recreational Boating Facilities Study – Planning for future Needs in May 2007, which indicated that within 15 years boating use along the coast and Swan River will double and that the stacking of boats at pens may be needed.

What is a Structure Plan and why do we need one?

A Structure Plan is a document that describes how a discrete area of land can be developed and how it should look and feel in the future.

A Structure Plan for the Marina could identify what should be part of the development – boat pens, recreation areas, natural bushland, restaurants and shops may be some examples.

Before the physical development of the Marina can begin, a Structure Plan is needed to guide development. This will need the support of Council and the WA Planning Commission.

Who will be consulted about this?

Consequently, the City is seeking views from those living in Ocean Reef where the Marina will be developed, people living in the surrounding suburbs, groups who may use the facility and people living in the North West corridor.



Water Corporation Considerations

Freehold Land Lot 1033.

The bold dotted line on the attached plan effectively divides the land north/south.


The area north of the line contains existing infrastructure (beenyup wastewater outfall pipes) and any surface use should allow for short notice access at any time. The Corporation's view is that the use should appear temporary i.e. gravel or limestone surface only. The capacity of the pipes will need to be increased in the future and there should be no restrictions on the Corporation's core business in this area.

The area south of the line does not have the same requirement for short term access however will form an integral part of any expansion/upgrade of the pipeline by forming a laydown and launch area. Under these circumstances a longer term lease arrangement is feasible with the capacity for the Corporation to give e.g. 2 years notice at any time should the area be required.

A sign will be erected indicating that the land will be required for Water Corporation future infrastructure.

Reserve Land 36732

The groyne was constructed for the purpose of launching the outfall pipe and is no longer required by the Corporation as the pipes sit on the ocean bed. Should the City still require then the Corporation is willing to relinquish the vesting of the reserve to enable DPI to vest this area in the City. If this occurs then the Corporation will require an easement to protect the infrastructure. No structures could be placed on this land to affect the Corporation's ability to access the pipes as required.





7.0 INDIVIDUAL GROUP AIMS, GOALS AND OBJECTS – (EXPRESSED THROUGH DRAFT CONCEPTS)

- Ensures existing residents east of Ocean Reef Road at RL 25 will retain their existing ocean views.
- Internal waterway possible below 6.0m contour in depression (no outlook presently) below
 6.0 m contour providing focus for all higher developable land.
- Substantial residential component possible.
- 400 boat pen harbour proposed.

Stage 1 - Background and Vision • Will be compressed into an 18 month timeframe. The starting point will be the 18 December 2007 Council meeting where the Community Reference Group will be selected and endorsed. The background studies and visioning work will continue to run concurrently. The background studies / reviews, technical visioning and workshop exercises to be completed by consultants by the end of November 2007, with the information to be made available for the first workshop of the Community Reference Group. Garry Hunt indicated that the Project Team Vision Workshop (item 16) and the Risk Management Workshop (item 17) should occur onsite with the Consultants and Steering Committee. Corporation technical representatives to also be included in meeting. Stage 2 – Business Case Approximately 160 days for completion – starting with workshop in mid December 2007. Draft preferred options to be completed by early January 2008. Consultants team to look at costings in early February 2008. Value management workshop will be conducted once costings are known. Documentation of options to be completed by end February 2008. Feedback from Property Consultants to be received in mid March 2008. Business case to be compiled and completed close to 31 July 2008. Garry Hunt identified that the City's budget planning cycle will occur during this phase and the need to estimate funding requirements for the following year. 
