There were in excess of 400 Electors and a number of Press Representatives in attendance.

The Chairman declared the meeting open at 1933 hrs.

The Mayor advised the public that due to safety reasons, the number of people in the room would need to be limited.

Discussion ensued in relation to postponing the meeting.

MOVED Cr Duffy, **SECONDED** Gentleman (name unknown) that the meeting be postponed and held at a later date at a larger venue.

The Mayor requested a show of hands, with the majority of people opposing the motion.

The Mayor declared the Motion

The Mayor then ruled that the meeting continue as this was the wish of the majority present.

This meeting had been called in accordance with the provisions of Section 171(4) of the Local Government Act, in response to a petition of Electors.

The purpose of the meeting was to discuss the proposed development of a second general aviation airport within the City of Wanneroo.

The Mayor introduced Councillors, invited guests and members of staff and invited Mr Doug Brindal, Director of Regional Policy, Department of Transport to address the meeting.

The Mayor also advised of a media statement released by the Minister for Transport, Mr Charlton and was requested to read this statement to the meeting.

The Mayor advised that the media Statement indicated the Government's decision to create a Ministerial Taskforce to look at alternative sites for a second general aviation airport for Perth. The Taskforce will consist of three North Metropolitan MLC's - Ross Lightfoot as Chairman, Iain MacLean and Graham Edwards.

Further discussion ensued in relation to the large number of people present who were unable to enter the function area and thus not participate in the meeting. Several venues were suggested as possible alternative locations for the meeting to be held.

It was also suggested that it would be advisable to re-schedule the meeting as soon as possible to a larger venue to enable all the people who tried to attend this meeting to voice their opinion.

The Mayor then stated his intention to close the meeting and reconvene it at a later date, at a larger venue and advised the meeting this would be advertised as soon as possible.

There being no further business, the Mayor declared the Meeting closed at 1945 hrs.
