# 4. **BUSINESS OUTSTANDING FROM PREVIOUS MEETING**

There was no business outstanding from the previous meeting.

## 5. ITEMS OF BUSINESS

5.1 Revised Concept Drawing for the Facility

Issues discussed were:

- Concern was about the number of parking bays and it was possible to reduce the number of bays, by:
  - (a) Use of existing bays in shopping centre;
    - This would require agreement with the strata company;
  - (b) Exercise of Town Planning discretion.
- Concern about the noise impact was discussed:
  - On residential development to the east;
    - Suggested the proposed building be moved eastward;
- Expansion of the Play Area;
  - Relocation of door (eastern).

## **Action City of Joondalup:**

- (a) Strata management company to be contacted to obtain an 'in principle' and 'subject to contact' agreement regarding the issue of a licence permitting using of the proposed facility to use the existing car bays in the shopping centre.
- (b) Consideration be given for the proposed building to be moved eastward (plans to be further revised).
- (c) Plans be further revised to relocate the eastern door of the Play Area.
- 5.2 Revised Estimates of Cost

Issues discussed were:

- Cost for furniture, floor coverings;
- Re-cost on reduced car parking;
- Cost of earthworks.

## Action:

- (a) City of Joondalup to provide cost for furniture/floor coverings for the next meeting.
- (b) City of Joondalup to provide re-cost on reduced car parking (seeking advice from Planning and Development).
- (c) City of Joondalup to obtain from the contractor an estimate of cost for earthworks for next meeting.

The Chairman left the meeting at this point the time being 18.10 hrs.

5.3 Project Justification & Funding

The Committee considered the issue of project justification to the Council and supportive applications for funding.

Mr Davis advised of additional groups in support of the project:

- Guides
- Martial Arts
- 1<sup>st</sup> Joondalup Scout Group

The Chairman returned to the meeting at 18.35 hrs.
