

**SUMMARY OF SUBMISSIONS ON THE CITY OF JOONDALUP COMMUNITY CONSULTATION PROCESS:
KINGSLEY COMMUNITY FUND**

Members of the community were asked to identify a suitable project for expenditure of the Kingsley Community Funds during a public consultation period which concluded on 5 December 2006. Opportunities for the community to provide their ideas were advertised in the Community Newspapers and on the City's website.

A summary of the proposals (using wording within the proposals where possible) the issues they are intended to address and any identified anticipated benefits of the proposals to the Kingsley Community is provided in the table below.

1	A new modern children's playground(s) for the suburb of Kingsley... where ... playgrounds were obviously established many years ago.	The unattractive appearance of ageing play equipment, which reduces community amenity for local residents. The existing playgrounds are old, the equipment is rusty / broken, with unsuitable flooring and without adequate shade from the sun.	1. Kingsley has a mix of residents... this project would benefit all - families with children and older couples with grandchildren. 2. The environment - we wouldn't have to use our cars to drive to suitable playgrounds in other suburbs. 3. Mums - as they fight the baby flab by being able to walk to the playground instead of hopping in the car.	\$15,000 dependent on the space available for installation.
2	A new skatepark. The nearest skatepark for anyone in Kingsley is in Cragie, which is sort of a long way to walk or skate. The maintenance (mowing) would not change as the whole area is mowed now. 2. Relocation of the practice wicket to the north western corner would remove the existing danger to YMCA after school care children from stray cricket balls 3. Cricket training would take place in the light (at present, the existing trees near the annexe allow very little sunlight through). 4. Benefits for the City, local sporting clubs, YMCA and others 	Unable to cost.
