# Local Government and Public Property Amendment Local Law 2007

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Joondalup resolved on \_\_\_\_\_\_ to make the "City of Joondalup Local Government and Public Property Amendment Local Law 2007".

In this local law, the *City of Joondalup Local Government and Public Property Local Law 1999* as published in the *Government Gazette* on 18 January 2000 and as amended and published in the *Government Gazette* on 15 January 2002 is referred to as the principal local law. The principal local law is amended as follows –

### **ARRANGEMENT**

PART 1 – PRELIMINARY	Clauses 1	-3
PART 2 – SHOPPING TROLLEYS	Clauses 4	$1 - 4^{-1}$

## PART 1 – PRELIMINARY

#### **Title**

This title may be referred to as the *City of Joondalup Local Government and Public Property Amendment Local Law 2007.* 

#### Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

## **Purpose**

The purpose of this local law is to amend a clause in the *Local Government and Public Property Local Law* to reduce the time available for owners to remove abandoned trolleys.

# **PART-2 SHOPPING TROLLEYS**

## **Amendment**

The City of Joondalup Local Government and Public Property Local Law 1999 published in the Government Gazette on Friday 27 August 1999, is hereby amended in the following manner:

# SHOPPING TROLLEY TO BE REMOVED BY OWNER

4.1 Amend clause 59 by deleting the numerals "24" and inserting the numeral "3" in its place.
