The Duban Commitment: Local Government for Biodiversity was developed, founded and signed by 20 Local Action for Biodiversity Local Governments:

as a commitment and model by local government, for local government and the communities they serve, to protect and enhance biodiversity at the local level.

This Commitment recognises that biodiversity is the variety of life on earth on which human well-being is dependent and that biodiversity provides ecosystem services that underpin all of our community's needs. Furthermore, it recognises that the value of biodiversity is multifaceted - including economic, tourism, recreational, environmental, heritage, stewardship, spiritual, intrinsic, medicinal, and social dimensions.

Through signing this Commitment we acknowledge that:

- i) Biodiversity is increasingly under pressure with unprecedented rates of loss due to human activities and over consumption of natural resources;
- ii) The global trend towards growth in urbanisation is placing ever increasing direct pressure on biodiversity at both the local area and through increased resource consumption and ecological footprints;
- iii) The impacts of climate change on biodiversity pattern and process will be significant. We need to build appropriate programmes to address, mitigate and adapt to these changes;
- iv) Future and ongoing human development is dependent on our ability to meet the biodiversity challenges we face;
- v) Ecosystem services can play an important role in poverty alleviation and consequences of biodiversity loss and ecosystem disruption are harshest for the poor;
- vi) It is our collective responsibility to reverse the current trends of biodiversity loss; and
- vii) Local government, that works most closely with communities and our biodiversity, has a critical role and responsibility (globally, nationally and locally) to ensure that biodiversity is conserved, protected, restored and sustainably used for the benefit of current and future generations.

Through signing this Commitment we hereby commit to promoting, increasing and enhancing the extent and quality of biodiversity within and beyond our administrative area and integrating biodiversity considerations into all aspects of our governance and development planning. We also commit to strengthen and prioritise efforts to control invasive alien species, to reduce the rate of biodiversity loss and to ensure that no further extinctions of indigenous species occur within our area of jurisdiction.

It is our intention to:

- i) Regularly publish Biodiversity Reports on the status of biodiversity in our administrative area and our progress in protecting biodiversity;
- ii) Contribute towards the formulation of global biodiversity good practice guidelines;
- iii) Develop and implement a local long-term Biodiversity Strategy;
- iv) Remain committed to ongoing implementation of that local long-term Biodiversity Strategy and to initiate the respective council decisions;
- v) Raise public awareness of biodiversity in all sectors of society;
- vi) Actively engage with, and ensure participation and involvement of all stakeholders; and
- vii) Actively participate in the ICLEI Local Action for Biodiversity Initiative as the global network of local government for biodiversity.

As a Local Authority, we support efforts to promote greater recognition by national governments and international bodies of the critical role local government plays in protecting biodiversity at the global level. We recognise our own role within the global environment and by signing this Commitment we entrench our dedication to global biodiversity by becoming a formal partner to Countdown 2010 by signing the Countdown 2010 Declaration, thereby committing to its targets, goals, objectives and principles.

Countdown 2010 Declaration

BIODIVERSITY - THE WEB OF LIFE ON EARTH - IS ESSENTIAL TO THE QUALITY OF HUMAN WELL-BEING, AND IT IS A CRUCIAL ELEMENT IN SUSTAINING THE SOCIAL, ECONOMIC AND SPIRITUAL DIMENSION OF ALL SOCIETIES WORLDWIDE.

YET, BIODIVERSITY CONTINUES TO DECLINE. POLITICAL COMMITMENTS HAVE BEEN MADE TO STOP THIS TREND BY 2010.

FURTHER STEPS NEED TO BE TAKEN TO HONOUR THIS COMMITMENT AND TO TRANSLATE IT INTO ACTION.

We the undersigned will take every practical opportunity to:

Support the commitments to halt or significantly reduce the current rate of biodiversity loss by 2010, made by:

- World Environment Ministers in the Hague Ministerial Declaration of the Conference of Parties to the Convention on Biological Diversity in the Netherlands 2002;
- World Heads of State in the Plan of Implementation at the United Nations World Summit on Sustainable Development in Johannesburg, South Africa in 2002;
- World Heads of State in the United Nations World Summit Outcome in New York 2005;
- a number of biodiversity related conventions and regional processes since 2001.

Encourage decision makers at all levels, in both the public and the private sector, to contribute to these commitments and to:

- Increase public awareness and participation for biodiversity conservation, including the promotion of exemplary activities towards the 2010 biodiversity target;
- Better integrate biodiversity considerations into all relevant sectors of public policy and economy;
- Undertake serious efforts to adapt human activities to the needs of natural systems;
- Support the development of suitable monitoring and indicator tools to assess the state of biodiversity in Europe.

Commit ourselves to encourage and assist decision makers and societies in achieving the 2010 biodiversity target, notably through:

- Actively promoting Countdown 2010 to focus attention and mobilise resources for achieving the 2010 biodiversity target;
- Significantly reducing our own impact on biodiversity.

In particular, we will:

- Develop a long term Biodiversity Plan.
- Promote biodiversity education within the Joondalup community through our sustainability forums.
- Promote biodiversity within the region through regional committees.
- Protect and enhance our wetlands through our Yellagonga Integrated Catchment Management Plan.
- Protect and enhance our coastal foreshore through our Coastal Foreshore Management Plan.
- Work with our young people through our School Connections program - Adopt-A-Coastline.
- Work with community groups through our Conservation Advisory Committee and Sustainability Advisory Committee.
- Monitor the impact on biodiversity through the development of appropriate biodiversity KPIs.

By signing the Countdown 2010 declaration, an organisation becomes a partner of Countdown 2010.

Partnership is open to organisations from all sectors and levels that can demonstrate their commitment to the 2010 biodiversity target.

Overarching goal:

That all governments and members of civil society, at every level, have taken the necessary actions to halt or significantly reduce the loss of biodiversity by 2010.

Objectives:

- Encourage and support the full implementation of all the existing binding international commitments and necessary actions to save biodiversity;
- Demonstrate clearly what progress countries are making in meeting the 2010 biodiversity target;
- Gain maximum public attention for the challenge of saving biodiversity by 2010.

Principles:

- Science based: all Countdown 2010 work will be underpinned by sound science and/or relevant practical conservation experience and will be carried out to the highest possible standard.
- Transparency: Countdown 2010 is committed to the principle of transparency in process and decision making.
 It will ensure public access to information, while respecting individual privacy and institutional confidentiality, as appropriate.
- Subsidiarity: the Countdown 2010 Secretariat will work at the most appropriate level (local, national, regional, multiregional) and it will only undertake those Countdown 2010 activities that partners are unable to undertake.
- Autonomy: Countdown 2010 is an independent alliance.
 It is governed by the will of its partners through the institutional mechanisms in place (Advisory Board and Partners' Assembly).

Dear Colleague,

In May 2008, Germany and the City of Bonn will host the upcoming 9th Conference of the Parties to the UN-Convention on Biological Diversity.

Cities play a key role in biodiversity. Their experience, their knowledge and their support may significantly contribute to global debates and strategies. Your involvement in the project "Local Action for Biodiversity (LAB)" is a wonderful example of this commitment. We hope that the activities of your city within the LAB project will be an essential input to the conference programme.

The Mayors Conference will bring together local leaders from cities advanced within the field of urban biodiversity. The conference shall interact with representatives of national governments and international experts from organisations such as IUCN, UNEP and ICLEI, with donors of local government projects, NGO representatives, the media, and high-level representatives from the German Federal Government. Not only will it offer the opportunity to meet with State delegates participating in COP 9, but also the prospect of raising voices vis-à-vis the international community debating global strategies on biodiversity. Acontribution of local governments will be included in the agenda of the High Level Segment.

I have sent this invitation to some 50 senior representatives of cities that have shown a special interest and commitment in the field of urban biodiversity, amongst them mayors from all the cities that are part of the "Local Action for Biodiversity (LAB)" Project. May I encourage you to also bring a young municipal leader from your city, best a young council member, to this event in order to enable the next generation of leaders to understand the relevance of conserving our natural resources, especially biodiversity.

This invitation is also addressed at a selected group of partners to local governments. Please note the conference dates in your calendar and let me know at your earliest convenience if you will be able to join us. If you are unable to attend, I would be grateful if you appointed a senior representative to attend in lieu.

Thanks to the financial support from the German Federal Ministry of the Environment, Nature Conservation and Nuclear Safety (BMU), your conference fees will be covered and you are invited to be our guest at all conference related-meals.


LOCAL ACTION FOR BIODIVERSITY (LAB)
