## 1.0 INTRODUCTION

---

The City of Joondalup recognises the importance of minimising the impacts of crime and promoting safety within the community.

In achieving these outcomes, the City has entered into a partnership arrangement with the Government of Western Australia to facilitate the successful delivery of crime prevention and safety initiatives.

A *Community Safety and Crime Prevention Partnership Agreement*, provided as Appendix 8.1, has been co-signed by the City of Joondalup and the Government of Western Australia. This agreement acknowledges that the State Government has a primary responsibility in law enforcement, policing, community safety and crime prevention. The City's role is a complimentary one, which has been reflected in this document.

The Office of Crime Prevention has provided the City with the necessary tools and frameworks required to develop and implement this Plan at a local level. The Plan has been developed with the involvement of State Government agencies, relevant local organisations and the community. A diagram illustrating the planning framework is provided at Section 1.5.

### 1.1 Purpose

The purpose of the *Community Safety and Crime Prevention Plan 2009-2011* (CSCPP) is to highlight current community safety programs and services within the City and to identify areas for improvement to guide future direction.

The objectives of the CSCPP are to:

- Sustain a partnership between the City of Joondalup, State Government agencies, the community and business to work towards community safety outcomes.
- Identify community safety and crime prevention priorities for the City of Joondalup by researching current criminal and anti-social activity and consulting with the community.
- Set up a process for monitoring and evaluating crime prevention initiatives and strategies that form part of the plan.
- Facilitate safer communities through community connectedness and community ownership.

The objectives of the City's CSCPP are consistent with the Western Australian Government's strategy *Preventing Crime: The State Community Safety and Crime Prevention Strategy 2004-2007*.

The City has utilised the five goals of *Preventing Crime* to guide the development of the CSCPP:

1. Supporting families, children and young people.
2. Empowering communities and regenerating neighbourhoods.
3. Identifying and tackling priority offences in Western Australia.
4. Reducing repeat offending.
5. 'Designing-out' crime and using technology.

## **1.2 What is 'Community Safety'**

Community safety can be linked to 'quality of life' where a high level of community safety enables residents to pursue all aspects of their lives without fear or hindrance from crime or anti-social behaviour. Community safety and crime prevention tackles issues that are both real and perceived, and as such, includes issues for addressing the fear of crime as well as actual incidence of crime.

While a 'safe community' can be difficult to define, improvements in real or perceived levels of personal/community safety in an area can support an attractive quality of life with a reduced fear and incidence of crime. According to the World Health Organisation "Manifesto for Safe Communities" *Safety is considered a fundamental human right, all people should have an equal opportunity to live and work in safe communities*

## **1.3 What is 'Crime Prevention'**

Crime Prevention refers to any measure taken to prevent crime and anti-social behaviour before it occurs. Risk factors such as age, education, income, employment and alcohol abuse are strong indicators of people at risk of both committing crimes and becoming victims of crime.

Social crime prevention is about reducing the desire to commit crime through strategies and programs that address risk factors. Situational crime prevention is about reducing the opportunities for crime to occur.

## **1.4 Partnership Approach**

The prevention and reduction of crime and its causes is the responsibility of each and every Western Australian. As such, undertaking these responsibilities is best achieved through partnership arrangements involving the WA Police, State Government agencies, local government and the community. This way, the whole community is contributing and working collaboratively to make the community safer and to prevent crime. The following external agencies are also in a position take a leadership role in community safety and crime prevention:

- State Government bodies including, but not limited to:
  - WA Office of Crime Prevention
  - WA Police
  - WA Alcohol and Drug Authority
  - WA Department for Child Protection
  - WA Department for Communities
  - WA Department of Corrective Services
  - WA Department of Health
  - WA Department of Housing and Works
  - WA Department of Racing, Gaming and Liquor
  - WA Department of the Attorney General
  - WA Fire and Emergency Services Authority
  - WA Public Transport Authority
- Commonwealth Government bodies including, but not limited to:
  - Attorney-General's Department
  - Australian Institute of Criminology
  - Centrelink
  - Department of Families, Housing, Community Services and Indigenous Affairs
  - Department of Health and Ageing

- Other local government authorities
- Co-agencies, working and technical reference groups
- Young people, families and senior persons
- Local primary, secondary and tertiary schools
- Local businesses
- Community groups
- Media
- Persons with disabilities
- The community at large, etc.

On 27 March 2008, the City of Joondalup and the Government of Western Australia signed A *Community Safety and Crime Prevention Partnership Agreement* (Appendix 8.1). This Partnership Agreement clearly defines the roles and responsibilities of each of the partners.

#### **1.4.1 What is the Role of State Government in Community Safety and Crime Prevention**

The State Government has primary responsibility for law enforcement, policing, community safety and crime prevention. The role of the State Government is to provide leadership and direction. Under the Partnership Agreement, the State Government acknowledges that all State Government departments and agencies have a role to play in community safety and crime prevention.

#### **1.4.2 What is the Role of Local Government in Community Safety and Crime Prevention**

Local government has an important, complementary role to play in the area of community safety and crime prevention. As the sphere of government closest to the community, local government is well-placed to have a pivotal role in addressing some of the issues surrounding community safety and crime prevention.

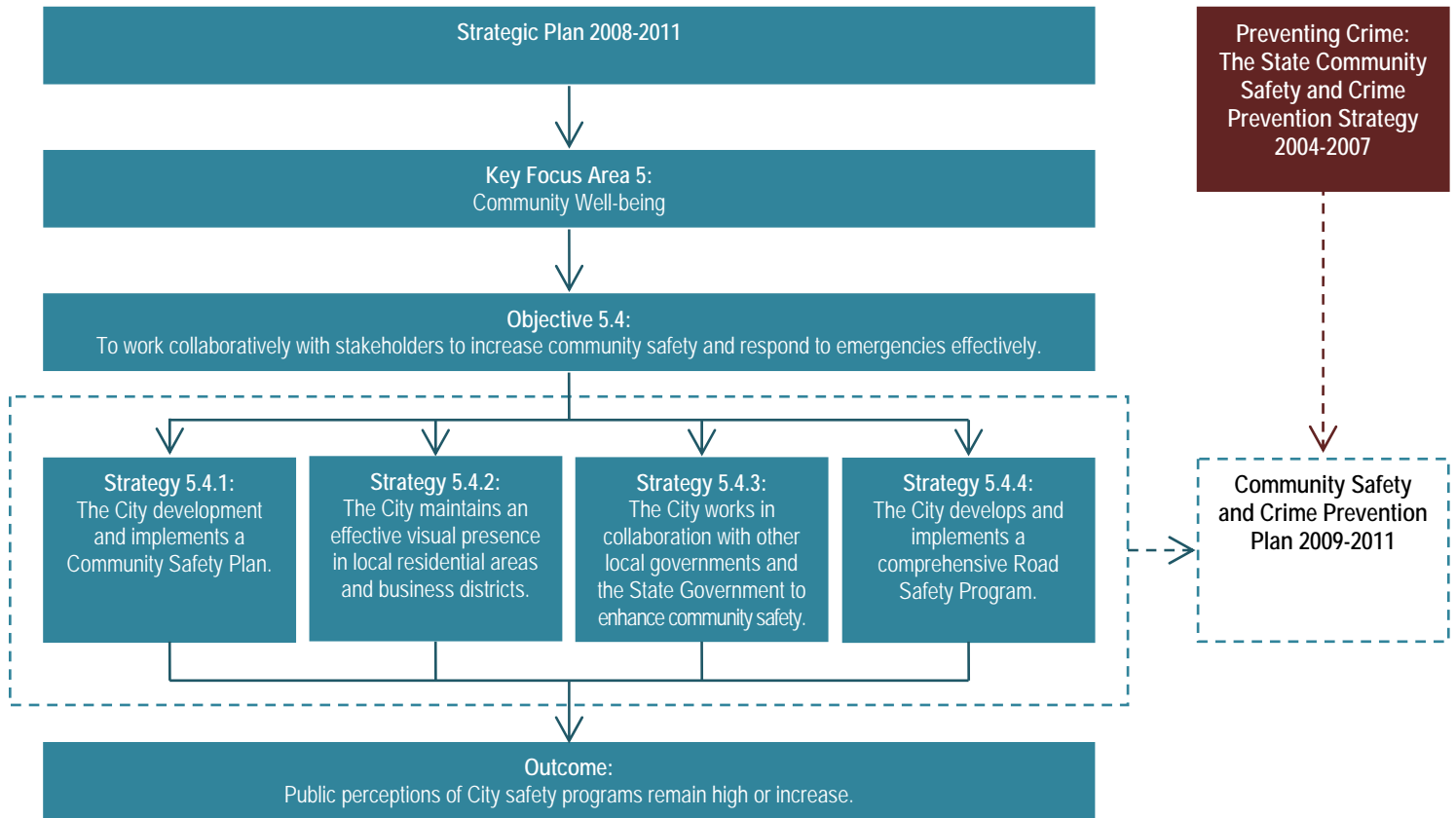
The City of Joondalup is committed to assisting the State Government in the delivery of the programs, projects and services outlined in this document.

### **1.5 Link to Strategic Plan 2008-2011**

The City's *Strategic Plan 2008-2011* drives the development of the CSCPP through the inclusion of specific objectives and strategies. The State's *Preventing Crime: The State Community Safety and Crime Prevention Strategy 2004-2007* informs the structure and content of the City's CSCPP. Both the City's Strategic Plan and partnership with the Government of Western Australia commit the City to co-ordinating the development of a CSCPP.

The City also has other Plans that do not relate specifically to community safety or crime prevention, but contain various actions and strategies that are relevant to this Plan. The City's CSCPP aims to consolidate these actions and strategies into one overarching document.

The following diagram illustrates the broader strategic planning context:



## **2.0 REPORTED INCIDENCE OF CRIME – STATISTICAL PROFILE**

---

The City of Joondalup has access to various data including: the *2006 Census of Population and Housing* from the Australian Bureau of Statistics (ABS); the *Community Safety and Crime Prevention Profile 2006-07* from the Office of Crime Prevention; quarterly offence data by suburb from the WA Police, and the City's own data from incident reports to City Watch. These data have provided information on the City's demographics, socio-economic indicators and actual incidence of crime.

### **2.1 Demographics and Socio-Economic Indicators**

The City of Joondalup is located in the northern suburbs of the metropolitan region, approximately 25 kilometres north of the Perth CBD. The City of Joondalup is bounded by the City of Wanneroo in the north and east, the City of Stirling in the south and the Indian Ocean in the west.

The City of Joondalup is predominantly residential, with some commercial and light industrial areas. The City encompasses a total land area of approximately 97 square kilometres, including substantial areas of coastline, parkland, foreshore reserves and bushland. The City of Joondalup includes the suburbs of Beldon, Burns Beach, Connolly, Craigie, Currambine, Duncraig, Edgewater, Greenwood, Heathridge, Hillarys, Iluka, Joondalup, Kallaroo, Kingsley, Kinross, Marmion, Mullaloo, Ocean Reef, Padbury, Sorrento, Warwick and Woodvale.

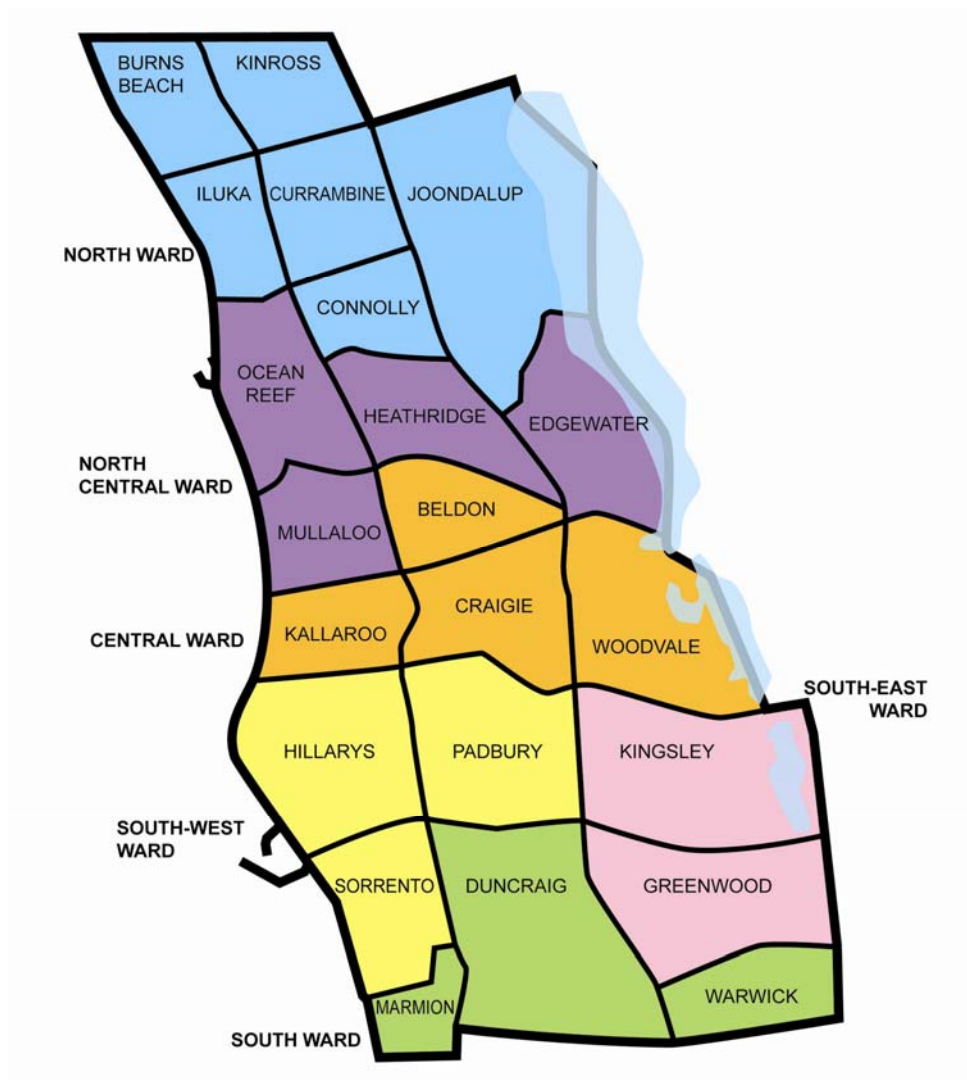
Area resource information drawn from the *2006 Census of Population and Housing* through the City's *Community Profile* software indicates that the City has a significantly higher than average income rate compared to the greater metropolitan region and a high percentage of families with teenage or adult children. The majority of residents in the City are homeowners, with a lower than average renting population. Approximately a quarter of the City's resident population are between 35 and 49 with almost 30% over the age of 50. Approximately 15% of the resident population are under 12, 10% between 12 and 17, and 20% between the ages of 18 and 24.

Socio-cultural data indicates that the City of Joondalup has a significantly high percentage of 'first-generation' immigrants, particularly from the UK, as well as higher than average English literacy. The cultural make-up of the City is therefore predominantly Australian- and UK-born. Higher Education levels of residents are also slightly higher than average, chiefly at the Vocational and Diploma levels. Less than half of the adult population have no qualifications, slightly less than the greater metropolitan region. Additionally, the City has a low unemployment rate of 3% with a large proportion of residents working in the industries of retail trade (12%), health care and assistance (11%) and construction (11%).

### **2.2 Actual Incidence of Crime**

According to the *Community Safety and Crime Prevention Profile 2006-07*, a total of 13,018 offences were recorded in the City of Joondalup in 2006-07, 7.7% more than in 2005-06. The most commonly recorded offences were 'other theft' (30.5%), 'property damage' (16.8%) and 'residential burglary' (7.1%). The rate of offence (ie: offences per 1000 persons) was lower across all categories compared to the wider North Metropolitan Region.

Long-term trends in the crime rate indicate that the City of Joondalup has experienced less crime than the wider North Metropolitan Region across all categories (with the exception of property damage from 1997-1998 to 1999-2000)



The key issues identified from the Profile include:

- Higher average in the category of '**aggravated robbery**' than in the North Metropolitan Region.
- Higher average in the category of '**other theft**' than in the North Metropolitan Region.
- Higher average in the category of '**threatening behaviour**' than in the North Metropolitan Region.
- A significant percentage increase in the categories of '**dealing or trafficking in illicit drugs**' and '**possessing and/or using illicit drugs**' since the 2005-2006 period.

Statistical data from the WA Police shows that the highest number of offences were recorded in Hillarys and Joondalup\*.

\* It should be noted that these two suburbs contain significant tourist facilities and are popular 'night life' areas within the City.

The key issues identified from this statistical data include:

- Significantly higher rates of **theft** in the suburbs of **Hillarys** and **Joondalup** compared to other suburbs in the City\*.
- Significantly higher rates of **assault** in the suburbs of **Hillarys** and **Joondalup** compared to other suburbs in the City.
- A significantly higher rate of **property damage** in the suburb of **Joondalup** compared to other suburbs in the City.

In addition to statistical data provided by the Office of Crime Prevention and the WA Police, the City of Joondalup records each occurrence of incident reporting to City Watch.

The key issues identified from this statistical data include:

- A significantly higher number of reports relating to the suburbs of **Joondalup** and **Woodvale** compared to other suburbs in the City.
- A significantly higher number of reports relating to **alarms / premised being insecure (for City-controlled buildings)** compared to other types of incidents reported in the City.
- A significantly higher number of reports relating to **noise complaints** compared to other types of incidents reported in the City.
- A significantly higher number of reports relating to **anti-social behaviour** compared to other types of incidents reported in the City.

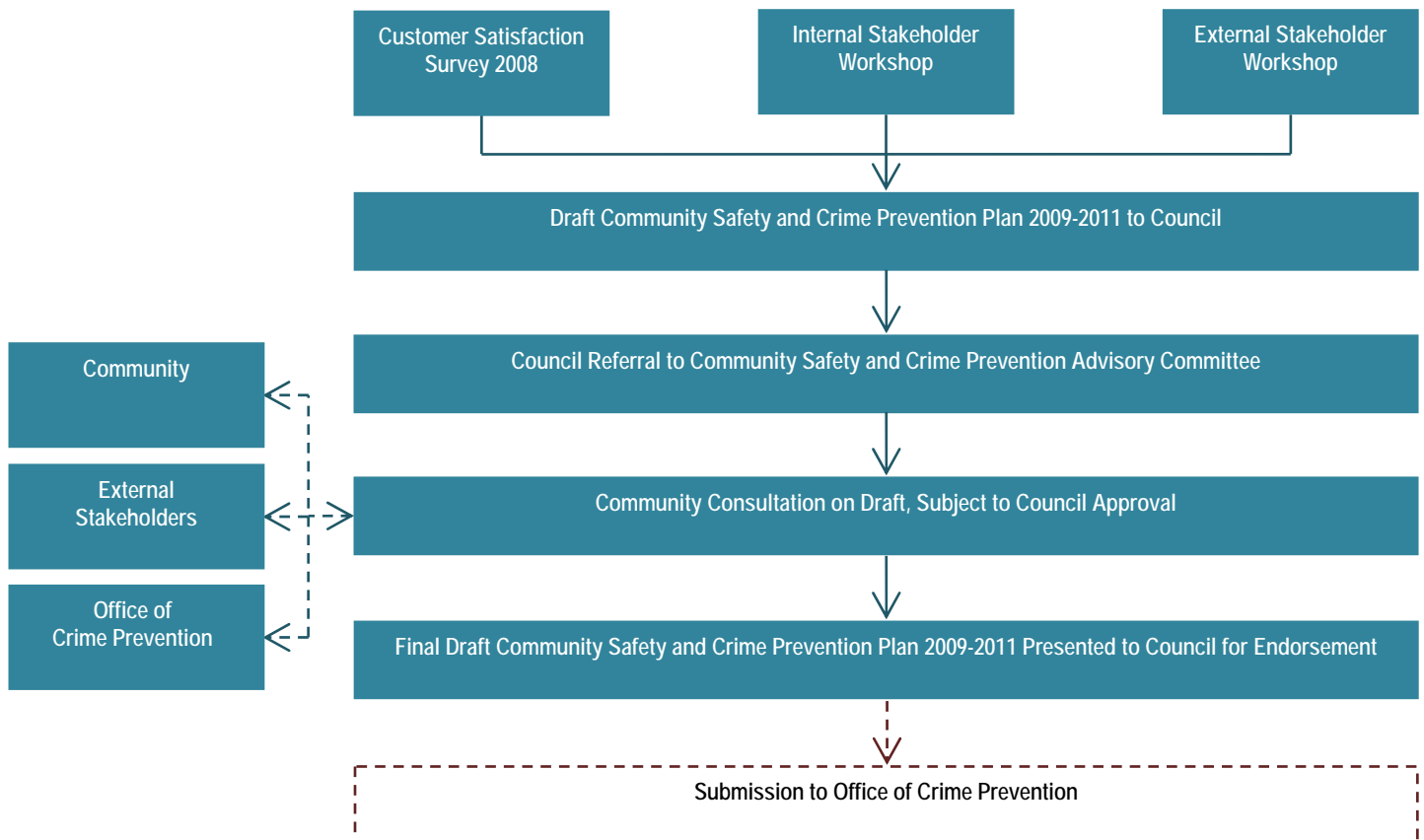
The key issues identified from this statistical data include:

- A significantly higher number of graffiti removals carried out in the suburbs of **Craigie, Kingsley, Heathridge, Hillarys, Duncraig** and **Joondalup** compared to other suburbs in the City.
- A significantly lower number of graffiti removals carried out in the suburbs of **Iluka, Burns Beach, Marmion** and **Edgewater** compared to other suburbs in the City.

### 3.0 COMMUNITY PERCEPTIONS OF CRIME – CONSULTATION

The City's CSCPP has been informed by consultation at various levels, all of which contributed to the Plan's development.

The following diagram illustrates the consultation process utilised by the City:



#### 3.1 Customer Satisfaction Survey

The Customer Satisfaction Survey (CSS) is an annual survey conducted by an independent market research company to measure the views of residents on the services provided by the City. The CSS is wide-ranging and deals with, among other things, community perceptions of various aspects of safety and crime prevention.

Results of the 2008 CSS rate the following services:

- Ranger Services: 79.6%
- Mobile Security Patrols: 63.3%
- Graffiti Removal Services: 74.4%
- Management and Control of Traffic: 77.9%

The table below summarises comments received from residents in relation to City services relevant to community safety and crime prevention. On occasion, the views expressed are contradictory, (eg: *need more mobile security patrols* and *don't need mobile security patrols*), these comments indicate the wide range of attitudes held by the community.

### 3.2 Internal Stakeholder Workshop

A cross-organisational workshop was conducted in April 2009 with key City of Joondalup staff from a range of different Business Units. Representatives attended from: Rangers, Parking and Community Safety; Infrastructure Management Services; Asset Management; Approvals, Planning and Environmental Services; Leisure and Cultural Services; Community Development and Libraries; and Strategic Development.

### 3.3 External Stakeholder Workshop

A workshop was conducted in April 2009 with representatives from various external organisations relevant to community safety and crime prevention in the City of Joondalup. The following organisations were contacted and invited to attend the workshop: Joondalup Police Station; Warwick Police Station; Hillarys Police Station; WA Police North-West Metropolitan District Crime Prevention Unit; WA Police Liquor Enforcement Unit; Lakeside Joondalup Shopping Centre; Department of Education and Training; Department for Child Protection; and the Public Transport Authority. Excepting the WA Police Liquor Enforcement Unit and the Department of Education and Training, all other invited stakeholders were in attendance. Those not in attendance were provided with the opportunity to comment during the community consultation process to ensure their views were incorporated in the development of the Plan.

This Workshop was conducted in an open discussion format and stakeholders were asked to complete a survey outlining the programs, projects and services administered from their

organisation. Given the broad nature of many of these organisations, only programs, projects and services where the City of Joondalup is a partner have been incorporated into this Plan. Relevant information received through the survey process have been included as actions in Section 5.0.

### 3.4 Public Submissions

Of 2200 surveys distributed to randomly selected households in the City of Joondalup, 451 were returned by the due date. This provides a response rate of 20.5%. The following tables provide a breakdown of the demographics of respondents by gender, age and suburb.

The feedback on overall responses to the full range of programs and services will be presented under the following headings:

- Supporting families, children and young people
- Empowering communities and regenerating neighbourhoods
- Identifying and tackling priority offences
- Reducing repeat offending
- 'Designing out' crime and using technology.

Commentary provided by respondents against individual programs was extensive. In this report, feedback for the programs receiving the most and the least public support in each category has been provided.

### **Supporting families, children and young people**

The services within this category were all supported or strongly supported and are rated as follows:

- COJ Youth Outreach Program 86.4%
- COJ Anchors Youth Linx 77.5%
- Lakeside Shopping Centre Youth Liaison Program 68.6%
- COJ Youth Mobile 76.3%
- COJ Youth Centre School Holiday Program 88.9%
- COJ Youth Projects 76.3%
- WA Police Blue Light Program 90.5%
- WA Police Constable Care Child Safety Program 91.3%
- Safety House Association Program 90.6%

A sample of the comments concerning the top rating Constable Care Child Safety program were as follows:

- *Teach them at an early age ie primary school*
- *Essential in today's society. The police offer fabulous role modelling to the young*
- *A healthy relationship with police officers is very important to avoid a 'them and us' attitude*
- *Absolutely! My kids are learning from this*
- *Essential programs like these promote respect for the Police*
- *I am aware of this program as are many West Australians. Ongoing success here hitting kids at the right ages.*

Comments concerning the City of Joondalup's Youth Mobile and other Youth Projects indicate considerable interest in the programs and how they operate, their availability and affordability. A sample of the comments is shown below:

- *Children need to be active and go somewhere so they are not causing trouble*
- *There seems to be a need for this around the Belridge High School and adjacent shopping centre!*
- *The increasing frequency of youth anti-social behaviour makes this a very high priority*
- *Definitely provide teens with activities to keep them from being bored*
- *Having a mobile utility to visit different locations is a great idea*
- *Again. Wonderful initiative keeping them engaged in 'how' or 'modern' activities - offering options for the more vulnerable young ones, gives them a chance to break away from unsavoury relationships*

### **Empowering communities and regenerating neighbourhoods**

The services within this category were all supported or strongly supported and are rated as follows:

- WA Police Neighbourhood Watch Program 92.4%
- WA Police Home Security Audit Service 72.4%
- COJ School Road Safety Program 85.3%
- COJ School Road Safety Art Competition 66.6%
- WALGA RoadWise Program 79.8%
- WALGA White Ribbons for Road Safety Program 38.1%
- Whitfords Volunteer Sear Rescue Service 93.1%
- Sorrento and Mullaloo Surf Life Saving Services 96.6%
- COJ Additional Summer Surf Life Saving Services 94.4%
- Worksafe 83.1%
- PubWatch 86.2%

In general, comments concerning the top rating Surf Life Saving Services were one-liners such as "Excellent," "So good." "Great service." On the other hand, WALGA's White Ribbons program was

not widely supported. The commentary indicates that the public were unconvinced of the program's efficacy in terms of influencing drivers not to speed and, as such, providing value for money. Comments received on the White Ribbons program included:

- *Unlikely to reach/influence those who do not drive safely and have no intention of not drinking and driving over the Christmas period*
- *I don't believe these types of symbolic measures have any effect*
- *one knows about it and seems to be ineffective in raising awareness.*
- *There are ribbons for many causes - no-one knows what they stand for*

### **Identifying and tackling priority offences in Western Australia**

The services within this category were all supported or strongly supported and are rated as follows:

- COJ Graffiti Reporting and Removal Program 93.5%
- COJ Community Speedwatch Program 86.2%
- COJ Community Safe Speed Promise Program 51%
- WALGA Road Safety Bin Sticker Program 69.4%
- COJ CityWatch Community Patrol Service 84.7%
- COJ CityWatch Holiday Alert Service 70.7%
- COJ CityWatch Party Alert Service 74.7%
- Office of Crime Prevention Eyes on the Street Program 86.2%
- COJ Ranger Services 90.2%
- COJ Events Management Community Safety Planning 78.8%

The top rating program in this category was the City's Graffiti Reporting and Removal Program. Most comments, however, related to the need to punish offenders in some way or at least have them involved in the cleaning up process. Comments included:

- *Strong fines and to clean up their own mess. Be proud of the City*
- *Harder penalties for "graffidiots" and their parents (of re-offenders)*
- *Graffiti, where possible should be removed by the taggers themselves. This would be their biggest deterrent*
- *We need to make all the graffiti vandals clean up their own mess!(If we catch them is the issue I suppose)*

Commentary on the COJ Safe Speed Promise Program indicates that, similarly to the White Ribbons program, the public are unconvinced of its efficacy as a way of influencing speeding behaviours.

### **Reducing repeat offending**

The services within this category were all supported or strongly supported and are rated as follows:

- DrugArm WA Street Van Outreach Service 80%
- WA Department of Racing Gaming and Liquor – Responsible Serving of Alcohol in Licensed Premises 83.6%
- COJ Local Graffiti Removal Volunteer Program 87.1%
- COJ Mural Art Program 67.3%

The top rating service is the COJ Local Graffiti Removal Volunteer Program. Similarly to the commentary provided about the COJ Graffiti Reporting and Removal Program, most people feel that graffiti removal should be something done by the perpetrators as part of their punishment. Receiving less support in this category is the COJ Mural Art Program. Of interest was feedback received independently from two respondents concerning a similar program that had become a tourism drawcard in Tasmania in recent years. This program has already been referred to the officer responsible for the Mural Arts program

### **Designing out crime and using technology**

The services within this category were all supported or strongly supported and are rated as follows:

- COJ Provision of Traffic Treatments 87.5%



- Main Roads WA Anti Hoon Speed Hump Program 74.3%
- COJ Crime Prevention through Environmental Design 72.2%
- COJ Public Areas Video Surveillance Project 88.9%

The top rating service is the COJ Public Areas Video Surveillance Project which the commentary indicates is a significant and necessary crime deterrent.

- *Almost 'absolutely necessary' unfortunately. Essential today. Cameras need to be good quality though*
- *Needs to be more. Put a few in high traffic areas in residential areas*
- *Important for providing evidence to police to up convictions and down crime.*
- *Strongly support this as we need to stop the "thugs" like those that injured Matt Butcher (he was looking out for our community and didn't deserve what happened to him!)*
- *Should be a lot more cameras around prone black spot areas*

Commentary provided on COJ Crime Prevention through Environmental Design indicates that a number of respondents did not understand how this program or activity of the City operated and that more information was required to be able to give an opinion. A sample comment is *"I don't quite understanding this one, so I cannot comment"*

## 4.0 IDENTIFIED PRIORITIES

---

The consultation process identified a number of areas that are considered a high priority by many respondents. Not all respondents indicated the same levels of support and between some respondents on some subjects, there were diametrically opposed views. In summary, and where there was broad support for priorities, these areas are described below.

- Support by the City for young people particularly in intervention/ support and youth liaison roles for youth “at risk” and also for the general youth population. It is acknowledged that young offenders should be supported by the state agencies responsible for Custodial, Family or other specialist services.
- Support for primary school programs that develop good relationships with the WA Police and which develop responsible citizenship as children grow into young adults
- Management of drugs and alcohol in society, particularly in terms of responsible consumption management
- Support for CCTV in areas where a demonstrated need has been identified, thus avoiding “big brother” concerns
- Support for the WA Police in a “Law and Order” context for managing all manner of anti social and criminal behaviour
- Support for restorative justice approaches, particularly in terms of graffiti offenders
- Neighbourhood Watch was identified as a program which is well used by those who know it but which could be promoted to a bigger range of potential participants with support from the City

## 5.0 CURRENT PROGRAMS

---

Outlined in the following Actions are the programs, projects and services relating to community safety and crime prevention that the City of Joondalup currently co-ordinates and those the City is currently involved in with an external partner(s). These Actions have been categorised under the five goals of the Western Australian Government's strategy *Preventing Crime: The State Community Safety and Crime Prevention Strategy 2004-2007*:

- 5.1 Supporting families, children and young people.
- 5.2 Empowering communities and regenerating neighbourhoods.
- 5.3 Identifying and tackling priority offences in Western Australia.
- 5.4 Reducing repeat offending.
- 5.5 'Designing-out' crime and using technology.

It is recognised that various external agencies are also involved in the delivery of programs, projects and services relating to community safety and crime prevention. However, given the limitations of the CSCPP, the Actions included in this Plan are restricted to those in which the City of Joondalup is directly involved.



**The prevention and reduction of crime and its causes is the responsibility of each and every Western Australian. The parties to this agreement recognise that the most effective approach to tackling crime and its causes to enhance community safety is through partnerships involving the WA Police Service, State Government agencies, Local Government and the community.**

**1. Title**

2008 City of Joondalup Community Safety and Crime Prevention Partnership Agreement.

**2. Partners**

The partners to this agreement are the Government of Western Australia (State Government) and the City of Joondalup.

**3. Purpose of the Agreement**

The State Government and the City of Joondalup recognise the important role each party has in the prevention of crime and sustainable community safety and security.

The purpose of this agreement is to:

- i. Acknowledge that the State Government has primary responsibility for law enforcement, policing, community safety and crime prevention.
- ii. Acknowledge the important role the City of Joondalup has to play in the area of community safety and crime prevention.
- iii. Promote the development and implementation of a *Community Safety and Crime Prevention Plan* for the City of Joondalup community.
- iv. Develop effective lines of communications between the State Government and the City of Joondalup.

#### **4. Principles**

The community safety and crime prevention principles that underpin this agreement are:

- i. Recognise that partnerships between the community, and State and Local Government are essential to achieve sustainable community safety and crime prevention outcomes.
- ii. Recognise and respect the role that State and Local Government plays in enhancing sustainable community safety and crime prevention.
- iii. Engage all levels of the community in working to reduce and prevent crime.
- iv. Develop an evidence-based and planned approach to crime prevention that focuses on areas of highest need and where outcomes can be observed.
- v. Continually work to improve the efficiency and effectiveness of government service delivery.
- vi. Promote fairness, openness and transparency in managing community safety and crime prevention planning and service delivery.

#### **5. Scope of the Agreement**

This partnership agreement commits the parties to:

- i. Supporting, coordinating and administering a local community safety and crime prevention partnership and developing and implementing a local *Community Safety and Crime Prevention Plan*.
- ii. Engaging and involving the whole community in planning and implementing community safety and crime prevention strategies.
- iii. Evidence-based decision making that targets areas of greatest need, and monitors and evaluates policies, programs and services.
- iv. Sharing information and experiences between the State Government and the City of Joondalup.
- v. Promoting greater community awareness and involvement in community safety and crime prevention efforts to reduce fear of crime levels.
- vi. Coordinating and integrating community safety and crime prevention activities through local service agreements between local government and State Government agencies.
- vii. Establishing measures to monitor progress towards improving community safety and reducing crime.

#### **6. Responsibilities**

##### **State Government**

- i. To provide leadership and direction for crime prevention in Western Australia.
- ii. To develop a State Crime Prevention Strategy.
- iii. To ensure that appropriate law enforcement strategies are maintained.
- iv. To support the City of Joondalup's community safety and crime prevention activities.



- v. To provide funds to support the City of Joondalup's community safety and crime prevention planning and initiatives.
- vi. To adopt a whole of Government approach to community safety and crime prevention and ensure that relevant State Government agencies participate in local *Community Safety and Crime Prevention Partnerships*.
- vii. To produce relevant data to assist the City of Joondalup in its community safety and crime prevention planning and activities.
- viii. To support the development of the City of Joondalup's capacity to participate in community safety and crime prevention by providing information and advice about "what works" and "what does not work" in crime prevention.

#### **City of Joondalup**

- i. To support, coordinate and administer local *Community Safety and Crime Prevention Partnership*.
- ii. To support and facilitate the development and implementation of a local *Community Safety and Crime Prevention Plan*.
- iii. To have a final draft plan submitted to the Office of Crime Prevention within 6 months of receiving the planning monies.
- iv. To ensure that the *Community Safety and Crime Prevention Plan* is consistent with the overall State Crime Prevention Strategy.
- v. To engage and involve the community, State Government agencies and non-government organisations in local *Community Safety and Crime Prevention Partnerships*.
- vi. To build the community's capacity to participate in the *Community Safety and Crime Prevention Partnership*.
- vii. To adopt evidence-based decision-making processes that target areas of greatest need.
- viii. To monitor and evaluate the effectiveness of community safety and crime prevention activities.
- ix. To build community capacity to participate in community safety and crime prevention by providing information and advice about "what works" and "what does not work" in crime prevention.

#### **7. Management**

The Office of Crime Prevention and City of Joondalup will manage this agreement jointly.

#### **8. Reviews**

This agreement will be reviewed in twelve months and thereafter every three years.


#### **9. Break Clause**
