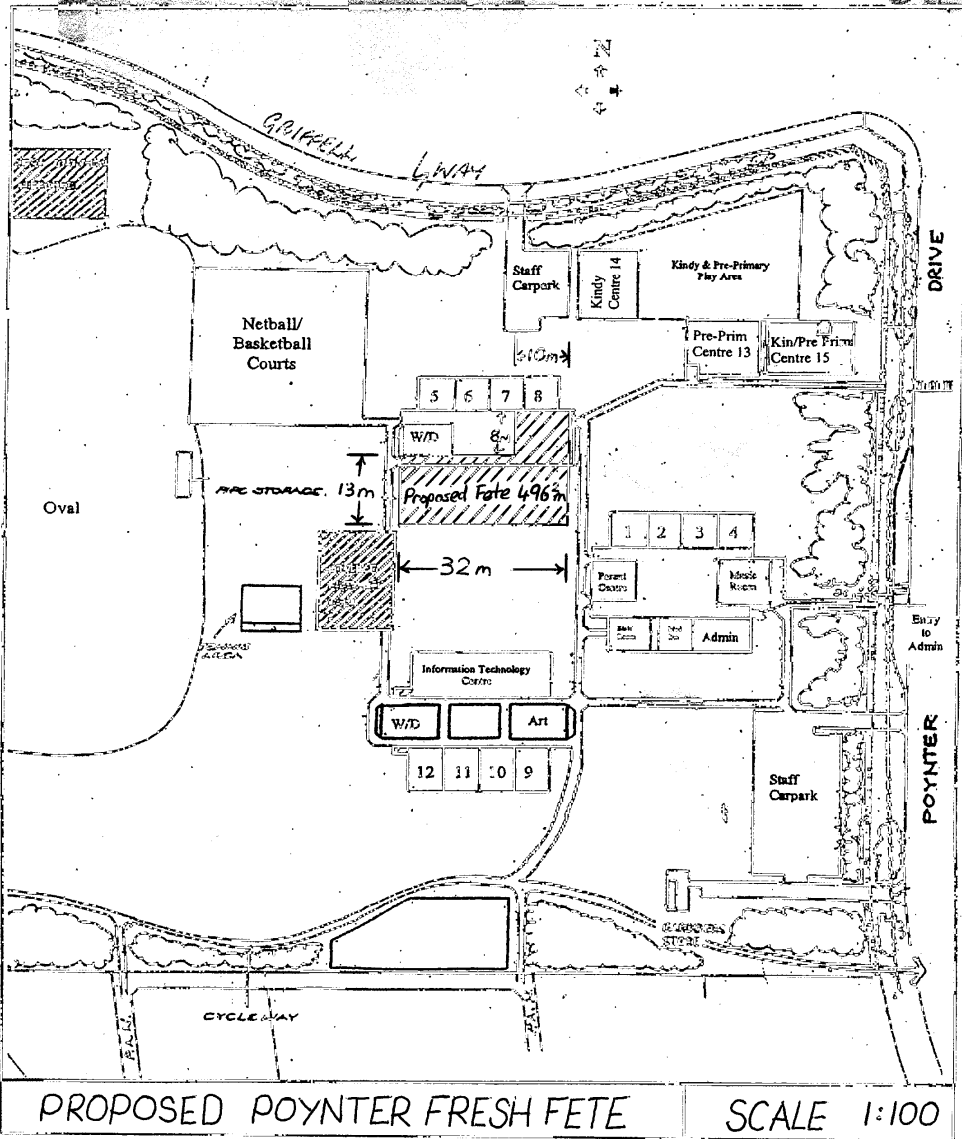


# MAP OF POYNTER PRIMARY SCHOOL

### SUMMARY

To succinctly summarise, this document sets out changes to *POYNTING THE WAY* and *THE CHARTER*. The core changes addressed are;

- 1 – Name change of event to *Poynter Fresh*.
- 2 – Relocation of *Poynter Fresh* on school site.
- 3 – Reduction in stall numbers.
- 4 – Stallholder setup times.
- 5 – Change of Opening and Closing Times.
- 6 – Noise Reduction.
- 7 – Traffic.
- ~~8 – Twelve week trial period.~~

### BACKGROUND

Whilst socio-political economies may grow, race, change and even stall; food as a basic tenet which strikes across the face of the agricultural, health, socio-political and, economic landscape at all levels and is one of the central keys in community's lives because food translates into better health and wellbeing for people.

#### 1 – NAME CHANGE OF EVENT TO *POYNTER FRESH*

In this context, the central key to our event is to provide *fresh food to eat and taste every time*. More succinctly and at an educationally primary level, governmental programs such as *Crunch & Sip*<sup>1</sup>, frequently brings together the student and their parents (as the food preparers) with basic fresh food such as fruit and vegetables so the student(s) can eat and taste food everyday in the classroom.

Within this context, the event held by the P&C is geared towards primary producers of food. This means 85% of the food on offer at the event will consist of meat, fish, vegetables and fruit. Further, fruit growers are keen to leave their weekly fruit and vegetable waste for the school to recycle and compost as well as, leave a portion of fruit in bowls for the students to ensure that there are choices for our students to enjoy a piece of fruit when they leave their respective classes at recess.

As a consequence, the name of the event has been changed to reflect a more concise name for the event and will be called,

**POYNTER FRESH**

celebrating

**F**ood to **E**at and **a**ste **E**very time

More importantly, the overarching term for our P&C's event centres on *fete*. This term is more concise than the previous use of the term *market* in the original application because the 3<sup>rd</sup> edition of the *Macquarie Australia's National Dictionary*<sup>2</sup>, clearly defines *fete* to mean;

*a function to raise money for charity, church, school etc., frequently outdoors and combining the activities of a bazaar and fair.*

Further, *The Australian Concise Oxford Dictionary 3<sup>rd</sup> Edition*<sup>3</sup>, clarifies *fete* to mean,

*an outdoor function with the sale of goods, amusements etc., esp. to raise funds for charity*

As well, the genesis of the term *fete* is from the french terms and defined by *Room*<sup>4</sup> to mean,

*an outdoor event with stalls and entertainments, usu. locally organized to raise money for charity.*

In this regard the core functions of our P&C (who are a charitable institution<sup>5</sup>) event is to hold;

- functions to raise money for our school,

- and the functions will be frequently held outdoors.
- The functions will have stalls by which the stallholders will sell goods,
- and the funds raised, as part of our core objectives<sup>6</sup> and as dictated by the *Education Act 1999*, will go towards *assisting in the provision of resources, facilities and amenities for the school*<sup>7</sup>.

### **2 – RELOCATION OF POYNTER FRESH**

At present, the current location of *Poynter Fresh* is sited on the basketball/netball courts of the school grounds. However, this amendment relocates *Poynter Fresh* to the middle of the school and will be sited onto the grassed area in between the Library, Undercover Assembly and class rooms (see attached photographs and site layout). In doing so, relocating *Poynter Fresh* will,

- Reduce the noise and impact on the adjoining residents to the school.
- *Poynter Fresh* is now physically further away from the adjoining residents and therefore, the expectation of noise coming from *Poynter Fresh* on the weekend is considerably less.
- The new site and its surrounding buildings will assist in noise reduction.
- Mains power will be made available to the meat supplier and coffee supplier.
- No generators will be used.

### **3 – REDUCTION IN STALL NUMBERS.**

The original application allowed between 29-39 stalls. The new amendment reduces the stall numbers to ~~between 15-20~~ stalls for the following reasons;

- By reducing the number of stalls, also reduces the number of patrons expected to come to *Poynter Fresh* and keeps the event centralised in the middle of the school.

### **4 – STALLHOLDER SETUP TIMES**

In keeping with noise levels to its minimum, the setup times for stallholders will begin from;

- 8am in the morning.
- No vehicles can move from 8:30am onwards.

### **5 – CHANGE OF OPENING AND CLOSING TIMES**

The opening and closing times for *Poynter Fresh* will change and operate at these times;

- 9am to 12pm

### **6 – NOISE**

Effectively by relocating *Poynter Fresh*, into the middle of the school and reducing the size of *Poynter*

*Fresh*, will indeed, reduce the overall noise levels expected in the original application in terms of,

- relocating the site to the middle of the school.
- reducing the stall numbers.
- Stallholder setup times shift to 8am-8:30am in the morning.
- Changing the opening and closing times to, 9am-12pm.

#### 7 – TRAFFIC

By relocating *Poynter Fresh* and re-scaling the size of the function, the traffic issue will also change from the original application. That is,

- The oval will only open up for the stallholders to bring the goods onto the site.
- The oval will now be closed to the public and all patrons will park in the staff car parks;
- Currently, there are 25 parking bays in the main car park and ~~6 bays in the Kindy car park.~~
- As well, there is on street parking at the front of the school to cater for the patrons.
- Also, the intention for the school student(s) and their parents, is to walk to *Poynter Fresh*.
- No traffic will be directed down Griffell Way or Lionel Court by *Poynter Fresh* volunteers.
- Poynter Primary School families will be required to walk to *Poynter Fresh* and thereby leaving the parking for those coming from further afield of the surrounding streets.

#### ~~8 – TWELVE WEEK TRIAL PERIOD~~

~~All of the changes in the above sections, will be subject to a twelve week trial period and then reassessed at the end of the period. It is intended for the trial period to operate in the following manner;~~

- ~~First six weeks, *Poynter Fresh* will operate fortnightly~~
- ~~Second six weeks, *Poynter Fresh* will operate on a weekly basis.~~

~~Thereafter, *Poynter Fresh* shall be re-tuned (where applicable) and will continue as a weekly event.~~
