To outline the Terms of Reference for the Joondalup Performing Arts and Cultural Facility Steering Committee.

#### **BACKGROUND**

At its meeting held on 22 June 2010, Council established the Joondalup Performing Arts and Cultural Facility Steering Committee (JPACF) (CJ103-06/10 refers), and at its meeting held on 21 September 2010, endorsed the Terms of Reference for that Committee (CJ150-09/10 refers).

#### **DETAILS**

The primary objective of the Steering Committee is to provide leadership and oversight of the planning and design for the JPACF. To achieve this objective the Steering Committee will provide direction on the scope of the potential design for the JPACF and determine the required reports and studies necessary to achieve Council's vision for the facility.

The endorsed Terms of Reference for the JPACF Steering Committee are:

- To provide advice and make recommendations to Council on:
  - The architectural design elements to be incorporated into the Joondalup Performing Arts and Cultural Facility;
  - The core components to be included in the Joondalup Performing Arts and Cultural Facility;
  - The capacity of the design features to be included in the Joondalup Performing Arts and Cultural Facility;
  - The options for the ongoing management and utilisation of the Joondalup Performing Arts and Cultural Facility.
- The authority to form a reference or working group (as deemed appropriate) to assist with the implementation of the required tasks.

#### **PURPOSE**

To outline the roles and responsibilities of the Joondalup Performing Arts and Cultural Facility Steering Committee.

#### **BACKGROUND**

At its meeting held on 22 June 2010, Council endorsed the Project Philosophy and Parameters and the formation of a Steering Committee for the Joondalup Performing Arts and Cultural Facility (JPACF) (CJ103-06/10 refers). Further, Council endorsed the Terms of Reference for the Steering Committee at its meeting held on 21 September 2010 (CJ150-09/10 refers).

#### **DETAILS**

The primary objective of the Steering Committee is to provide leadership and oversight for the planning and design for the JPACF. To achieve this objective the Steering Committee will provide direction on the scope of the potential design for the JPACF and determine the required reports and studies necessary to achieve Council's vision for the facility.

#### **Roles and Responsibilities**

The role of the Steering Committee is to provide expert advice on this project, and it plays a vital part in informing the decision making process of the Council. The Committee provides Council with the opportunity to obtain the view of strategic user groups who are represented through the Committee's membership, and gain an appreciation and understanding of, amongst other things, the needs of those groups in progressing this strategic project.

In establishing the Philosophy and Parameters for this project, Council has articulated both its objectives and purpose, and Council's intent to progress the project. The Steering Committee has a responsibility to ensure that recommendations reflect and affirm Council's philosophy for the JPACF (Attachment 1 refers).

#### **Code of Conduct**

The Local Government Act 1995 requires the City to adopt a Code of Conduct that applies to Elected Members, Committee Members and employees. As a Committee of Council, the JPACF Steering Committee is governed by this Code (Attachment 2 refers).

The Code of Conduct provides a framework for behaviour that must be observed in your dealings as a Committee Members for the City.

By providing a signed statement acknowledging that they have read the Code of Conduct, Committee Members agree to abide by requirements of the Code.

# Confidentiality

The Steering Committee is a Committee of Council that is not open to the public, and as such there are certain provisions related to the use of information that Committee members should be aware of.

Council members, committee members and employees shall not use confidential information to gain improper advantage for themselves or another person or body in ways which are inconsistent with their obligation to act impartially in the public interest; or to improperly cause harm, detriment or impairment to any person, body, or the Council.

Due discretion shall be exercised by all those who have access to confidential or sensitive information. Every matter dealt with by, or brought before, a meeting sitting behind closed doors, shall be treated as strictly confidential, and shall not without the authority of Council be disclosed to any person other than Council members and/or employees of the City (and in the case of employees only so far as may be necessary for the performance of their duties) prior to the discussion of the matter at a meeting of Council held with open doors.

All documents of the City of Joondalup that are marked 'CONFDIENTIAL' or 'NOT FOR PUBLICATION' or marked with a clear message that the document is intended for the recipient only, are confidential to the City of Joondalup and shall not be published, copied, reproduced or the contents released to another person, in whole or in part, in any manner whatsoever without the express permission of the Council or the Chief Executive Officer.
