
Proposed Tennis Court Facility Hierarchy


This Tennis Court Facility Hierarchy has been developed to determine the minimum review level for restorative works for the different types of tennis court facilities in the City. The facilities have been defined as either 'Regional', 'District', or 'Local' with associated minimum review levels of 8 years, 10 years and 12 years.

	No. courts	Affiliated club	Min. review level
Regional	> 15	yes	8 years
District	5–15	yes	10 years
Local	< 5	no	12 years

Using this Strategic Framework, the City has determined the facility type and minimum review level for each of the tennis court facilities in the City:



FENTON RESERVE TENNIS COURT DECOMMISSIONING – FREQUENTLY ASKED QUESTIONS

1. What is the purpose of the community comment period?

To provide the local community with an opportunity to indicate their preferred option for replacing the tennis court, fencing and floodlighting at Fenton Reserve.

2. Where is Fenton Reserve?

Fenton Reserve is a local park located on Fenton Way, Hillarys. Current infrastructure at the site consists of a single fenced floodlit tennis court, a swing set and picnic table.



The tennis court, fencing and floodlighting is being removed by the City, following a decision of Council at its meeting in December 2012.

3. Why is the tennis court being removed?

The Fenton Reserve tennis court has very low utilisation levels and is used less than 0.5% of its available time.

There are also costs incurred by the City in maintaining tennis courts that are underutilised, particularly with regard to their resurfacing and lighting requirements. As such, the City has developed a decommissioning process to determine the circumstances in which tennis courts may be considered for removal and replaced with alternative landscaping and/or infrastructure that will improve the utilisation of the space and reduce the operational costs of maintaining under-utilised infrastructure.

4. Are there alternative tennis courts nearby?

Yes. Hillarys has a number of other tennis court facilities located in the suburb. Harbour View Park has two tennis courts and is approximately 1 kilometre south-

west of Fenton Reserve. James Cook Park also has two courts and is approximately 1.5 kilometres north of Fenton Reserve.

5. What will the tennis court be replaced with?

Given the size of Fenton Reserve, limited infrastructure will be considered to replace the tennis court.

One option is to replace the court with grass. Given the court is in the middle of Fenton Reserve and is surrounded by grass, this would be in keeping with the surrounding area and give the local community more grass for informal recreation and play.

Another option is to replace the court with grass and also some additional planting of native vegetation and a park bench.

6. Who is being consulted?

The City is directly consulting with residents living within a 200 metre radius from the site.

However, anyone interested in the proposed development can also be involved in the consultation by completing the survey online at the Community Consultation page on the City's website at <u>www.joondalup.wa.gov.au</u> or forms are available on request by telephoning 9400 4221.

7. How will this project be funded?

There are funds allocated for this project within the City's 2012/13 Capital Works Budget.

8. When does the community comment period close and how can I make comment?

The comment process will commence on Monday 18 February 2013 and will conclude on Monday 11 March 2013, allowing a three week period for people to indicate their preferred replacement option.

Comments can be made by completing and returning the survey to the City with the reply paid envelope or alternatively, the survey can be completed electronically via the Community Consultation page on the City's website, www.joondalup.wa.gov.au.

9. What happens next?

The results of the community comment period will be collated and presented to Council for consideration.

The overall results on this consultation will also be available on the City's Community Consultation page for viewing, with individual responses remaining confidential.
