Its proposed methodology included an indicative program and an outline of tasks to be carried out. The Gantt chart supplied shows timeframes in line with the specification. The company will utilise two crews for the installation of the irrigation systems and works will be carried out concurrently on both Mawson and Hillarys Parks.	It was established in 1991 and currently employs 250 full-time staff. The structure of the company (irrigation division) and details of key personnel including their qualifications, length of service and industry experience were provided. It has four crews of permanent fulltime subcontractors, each crew equipped with its own excavator and bobcats. A list of general equipment that will be used to carry out the works was supplied. It operates with its own quality management system and has an OSH policy in place.	It stated that the company has over the past three years successfully completed numerous projects similar in scope to the City's requirement. Examples of works recently completed for a number of private organisations and local governments, including the Town of Claremont, Cities of Stirling, Canning and Melville were provided. However, it did not include scope of work carried out for these clients.	The company is located in South Perth. No response was supplied for this criterion.	66.8%	\$368,886	1

Some works to be completed by others were included in its list of tasks to be undertaken.	It is a well established company. It has been in the irrigation industry for over 35 years and now employs over 400 staff across Australia. Details of key personnel including their positions and years of industry experience supplied. A list of specific equipment including trench diggers was also supplied. It would allocate more resources as required. It operates with its own quality management system and has an OSH policy in place.	It has extensive experience in completing similar projects for various organisations including local governments. The company has recently completed similar works for the Cities of Stirling and Cockburn. Numerous example of smaller and large scale commercial irrigation works undertaken in the past were also provided.	Its Perth office is located in Bibra Lake.
