ELLERSDALE PARK – PROPOSED UPGRADES – ANALYSIS REPORT

The following provides an analysis of the quantitative and qualitative data gathered from the *Ellersdale Park – Proposed Upgrades Consultation* conducted with ratepayers and residents between **26 August 2015** and **16 September 2015**.

BACKGROUND

Consultation Development

The City consulted directly with all ratepayers and residents that lived within a 200 metre radius of Ellersdale Park and Community Engagement Network members who lived in Warwick.

A personalised information package was sent to each ratepayer explaining the purpose of the consultation and advising them of the consultation period. Each package included:

- A covering letter;
- Frequently asked questions containing information on the purpose of the consultation and the proposed options; and
- Hard copy survey to determine the level of support from households.

Details and information regarding the consultation were outlined on the City's website and two status updates were posted on the City's Facebook page. In addition, the consultation was also advertised through the Joondalup Weekender (27 August 2015). Members of the public and stakeholders wishing to comment were also encouraged to complete a survey form online via the City's website.

SURVEY DEMOGRAPHICS

Response Rates and Validity

(N.b. unless otherwise stated, "%" refers to the proportion of total survey respondents.)

Hard-copy surveys were sent to all 308 ratepayers within a 200 metre radius of Ellersdale Park. The City collected a total of 79 responses throughout the 21-day advertised consultation period. The response rate for the survey was 25.6%. Of those responses, 78 were deemed valid¹. This data has been summarised in Tables 1 and 2.

Age


Of the 78 valid responses, the majority of respondents were aged 60–69 (29.5%), 70–84 (25.6%) and 35–49 (14.1%). This data is summarised in Table 3 and Figure 1 below, with direct percentage comparisons with the suburb of Warwick and the City of Joondalup.

People aged 35–49 and 50–59 represented a significant segment of the local population, which is consistent with the response rates. It should be noted that the 60–69 and 70–79 age group was over-represented whilst the 18–24 and under the age of 18 age groups were under-represented in this survey response.

Respondents were asked to rate the level of support for the potential options outlined below.


a. Installation of a tennis hit-up wall

Figure 2 – Summary of the Question 1a





b. Installation of a 3-on-3 basketball pad
