It has more than 30 site staff and listed 10 subcontractors. Many of the subcontractors worked on the original construction and the nominated project manager was the site manager for the project under previous employment with CPD Group. It nominated two afterhours contacts. The company has sufficient internal capacity to provide any additional resources that are required. The company operates a certified AS/NZS 4801 safety management system and has had no safety incidents in the 2014/15 and 2015/16.	McCorkell Constructions demonstrated experience completing similar refurbishment projects. Three examples were supplied supporting the experience. These were the Medina Hall refurbishment completed in 2014 for the City of Kwinana (\$1.6M), North Cottesloe Primary renovation of a heritage army building completed in 2014 (\$1.7M) and Bakers House extension and refurbishment completed in 2012 for the City of Armadale (\$1M). The nominated referees are: City of Armadale, City of Kwinana and Parry & Whyte Architects.	The company demonstrated a thorough understanding of the requirements. The methodology set out staff responsibilities, deployment, risk assessment, safety, a project specific construction methodology and program. The response addressed the use of subcontractors that worked on the project before and warranting previously completed work.	The company is located in Perth. The company operates an accredited ISO AS/NZS 4801 safety management system and provided its safety policy statement and safety record of 2012-2015.	Advanteering demonstrated limited experience in projects of a similar nature to the SES facility extension. Six example projects were supplied in the offer; however the three projects set out in detailed project sheets were for a Museum street enhancement, Oxford Street reserve redevelopment and a commercial unit construction. Only the commercial unit construction had elements of similarity to the SES facility extension. The three other projects were listed in title description only as renovations with values between \$100k-\$150k. The nominated referees were: City of Perth, City of Vincent and Downer-Mouchel. The company demonstrated experience undertaking refurbishment projects. Eight example projects were provided in the value range of \$65k to \$768k. Works included refurbishment and extension of rooms in nursing homes, a refit of a works depot, refurbishments and construction projects in two primary schools, a hanger rebuild at the Maylands police complex and construction of new sports clubrooms at Houghton Park for the City of Wanneroo. These included Osborne Park Bowling Club (\$183k), Nollamara Community Centre (\$205k) and Yokine Bowling Club (\$183k) for the City of Stirling, Oldham Community Centre Multipurpose Room extension (\$250k) for the City of Wanneroo and an extension to the Town of Mosman Park works depot (\$95k).
