OVERVIEW

From 9 November 2018 to 22 November 2018, all 12 football (soccer) clubs in the City of Joondalup were invited to provide feedback through the Survey of Football (Soccer) Clubs. Feedback was sought by way of an online survey form which was distributed to clubs via direct email.

The City collected a total of 7 responses throughout the 14-day advertised engagement period from the following clubs:

- Joondalup City Football Club
- Joondalup United Football Club
- Kingsley Senior Soccer Club
- Perth City Soccer Club
- Sorrento Football Club
- Whitford City Football Club
- Woodvale Football Club

Respondents were asked to provide a number of demographic details to enable the City to gauge the level and breadth of football currently being played across the City. 5 respondents indicated that they collectively had 182 junior teams; 7 respondents indicated that they collectively had 41 senior men's teams; and 4 clubs indicated that they collectively had 7 senior women's teams.

A total of 3 clubs indicated that they are currently taking steps to meet the National Premier League Compliance Regulations from Football West, and 1 club indicated that they already met the Regulations. Overall, 5 respondents indicated that they either "support" (1) or "strongly support" (4) the establishment of a football facility built to National Premier League standards in the City of Joondalup. 3 respondents indicated that they would be interested in using such a facility as part of a shared-use arrangement. Further, respondents indicated that responsibility for funding the establishment of a football facility built to National Premier League standards should primarily lie with state government (7), local government (5), and clubs (4).



RESPONSE RATE

The City collected a total of 7 valid responses throughout the 14-day advertised engagement period. Responses that were considered valid include all those which contain contact details enabling identification and were submitted within the advertised engagement period. Where multiple Comment Forms were received from the same respondent, these were combined into one response.


DEMOGRAPHICS




SURVEY FORM QUESTIONS

Is your club taking steps to meet the National Premier League Compliance Regulations:





Does your club aspire to compete at the National Premier League level:





Does your club support or oppose the establishment of a football facility built to National Premier League standards in the City of Joondalup:




QUESTION: "Who do you believe should be the most responsible for funding the establishment of a football facility built to National Premier League Standards?"

Respondents were asked to indicate who they believe should the most responsible for funding the establishment of a football facility built to National Premier League Standards. All respondents (7) indicated that the state government should be responsible, 5 respondents indicated that local governments should be responsible, and 4 respondents indicated that clubs should be responsible. 1 respondent selected "other" and described a shared funding model. Who do you believe should be the most responsible for funding the establishment of a football facility built to National Premier League Standards:




QUESTION: "Would your club be interested in using such a facility as part of a shared-use arrangement?"

QUESTION: "Do you have any further comments about support for football clubs in the City?"

Respondents were asked if they have any further comments about support for football clubs in the City. All respondents provided feedback. Verbatim comments have been randomised and are provided in the table below.

Verbatim responses^{*} — Do you have any further comments about support for football clubs in the City? (N = 7):

While we agree that there needs to be an 'elite' or 'high performance' football centre in the City, no community or existing clubs should lose ground or facility access as part of this process. Community clubs provide access to sport for all socio-economic back grounds and enable young people to be active and healthy with their friends. There are a lot of clubs in the City now, so Football West should not allow any more clubs to be established as there is already too much pressure on the existing grounds in the City. Clubs are already competing with each other for players and facilities. If the City builds an elite football centre, it should not be for one club and should be shared by NPL clubs on a user pays system. That way, if clubs get relegated, or find that cannot continue in the NPL, the facility is available for other clubs with NPL aspirations. The current Arena site could be an ideal location for an elite football centre as it already has gyms, medical support, recovery facilities, parking, public transport etc.

I feel that for the amount of time donated by volunteers to ensure a club can fully function, that is not matched by FW or the Councils. Today's clubs seem to need to be administered 12 months of the year!

NPL ground requirements are a bit of a farce with many grey areas through the governing body Football West. If a facility is to be built, it should be ground–share basis and at Arena Joondalup or McDonald Park, Padbury. Gate and Bar should be the clubs for each of their games. Why can't the main pitch at Arena be used as ground share with the AFL for games? There are already grounds that can be used for ground share, eg Percy Doyle.

We are looking to continue building the brands of both Kingsley and Westside; should the merger be successful, we do have logistical limitations at Chichester Park, notwithstanding upcoming developments. We are looking to push our Sunday Premier League sides into Saturdays and driving towards NPL in the future. For more information please contact [- - -] who is your regular [- - -] contact.

Football is a massively growing sport, particularly in the Northern Suburbs. However, I think that prior to the large expenditure on this project, which will only benefit a small proportion of end users, facilities for grassroots football clubs need to be addressed first. Things like lighting, storerooms, and clubrooms for community clubs should be priority areas of focus for the City.

Why didn't you help us in 2017 & 2018 to stay in the NPL as, because of your lack of support, we had to leave the NPL due to lack of funding, lack of a home ground, lack of adequate training grounds with lights.

With a shared-use arrangement — every club would require its own area for bar/kitchen storage, preparation & sales.
