A local law amendment will be submitted to a future Council meeting to consider detailing any possible changes that can be made.</p> <p><b><u>Update as at February 2021</u></b> A report will be presented to the 16 March 2021 Council meeting to consider the draft <i>Advertisements Local Planning Policy</i> following public advertising, which details signage requirements on private property.</p> <p><b><u>Update as at November 2020</u></b> A new draft policy was presented to Council at its meeting held on 20 October 2020 (CJ162-10/20 refers).
