It has been the incumbent provider of this service to the City for the supply, delivery and installation of gates, bollards and bushland fencing since 2019, with previous experience delivering similar services to the City prior to 2012. It provided a detailed organisational chart and named 7 key personnel along with their qualifications, licenses, industry experience and length of service. Details of its specialised equipment was provided including type and model. Natural Area Holdings Pty Ltd operates a Quality Management System which complies with the requirements of ISO 9001:2015 and an Occupational Health and Safety Management accreditation. The company demonstrated sufficient capacity to provide the services.	It demonstrated a good level of experience in providing various conservation fencing to several local and state governments, providing details of clients, scope of works, periods and similarities. Detailed examples included; City of Swan - 56 metres of treated pine domed top bollards (2020), Department of Planning, Lands and Heritage - Fencing Repairs and Maintenance (2019), City of Canning - Conservation Fencing (2020), Rottnest Island Authority (2021) - Supply and install Jute Matting and Fencing and pine posts, Department Fire and Emergency Services - Supply and installation of pine post fencing (2020).	The company demonstrated a good understanding and appreciation of the City's requirements. It's methodology included its understanding of bollard installation and removal, bushland, track and path fencing installation and removal, and pedestrian, field and boom gate installation. It also provided timeframes required for various work requirements once a purchase order is issued by the City. It referred to its Traffic Management and Dial Before You Dig requirements and adhering to vehicle speed limits on parks and reserves.	It stated that it often purchases supplies from retailers within the vicinity of the City and provides full time employment for 8 staff from the locality of Joondalup. The company demonstrated sufficient capacity to provide the services.	Agrimate Pty Ltd demonstrated experience undertaking three fencing projects at the City of Armadale for the supply, installation and maintenance of fencing (August 2020), Perth Transport Authority for 18 Kilometres of security fencing (June 2020) and Acacia Prison for removal, disposal and installation of 2500 metres of ringlock fencing (May 2021). Only the project for the City of Armadale had significant similarities to this scope of work.	It demonstrated a reasonable understanding of the required tasks, providing its Service Delivery Process" which included a "Job Brief". Information contained within a Job Brief included development of the job scope, fence and post installation processes and tasks, material and tool types and requirements, concrete pouring, clean-up and handover. It referred to its operations managers "work schedule" however no timeframes for the work was provided. Barra Civil and Fencing Pty Ltd All requirements have been met.	Yes	The company is located in Bullsbrook with a remote office in Hillarys. It was founded 35 years ago. It provided an organisational chart and details of 9 staff including their roles and relevant experience. It included a broad range of products and services it offered to its customers, but most of the products and services were not necessary for this requirement. A list of its equipment was included but information was basic and limited to descriptions only, no quantities were included. The names and contact numbers of two of its management team was given but did not confirm if they were to be used as after-hours contacts. Copies of a number of its policies and plans were provided. Barra Civil and Fencing may have the capacity to deliver the service.	Barra Civil and Fencing demonstrated some experience providing fencing services to the Cities of Wanneroo, Melville and Swan and the Department of Planning, Lands and Heritage, but similarities were not evident. It provided commencement dates only of 5 current contracts it held with these organisations, but only the contract titles were provided, no scopes or outcomes was given. It referred to an employee who previously serviced the City fencing requirements.	The company did not fully demonstrate its understanding of the City's requirements. It provided only a single page methodology with minimal details, no method of approach fully relevant to the requirements or tasks. It did briefly refer to job commencement and completion timeframes in general.	Barra Civil and Fencing has an office located in Hillarys with staff located within the City.
