# OVERVIEW

The community was invited to provide feedback from 10 May 2022 to 30 May 2022 on a proposed sports floodlighting upgrade for Forrest Park, Padbury. The City collected a total of 111 valid responses throughout the 21-day advertised consultation period, including 13 from residents and landowners within 200 metres of Forrest Park, and 3 from park user groups, including:

- Northern Warriors Veterans Football Club
- Whitford Junior Football Club
- Whitford Amateur Football Club.

The majority of respondents indicated that they were residents of the City of Joondalup, and almost 60% indicated they were a member of the Northern Warriors Veterans Football Club.

Respondents were asked to indicate their level of support for the proposed sports floodlighting upgrade on a 5-point scale from “strongly support” to “strongly oppose”. The majority of respondents indicated that they “support” or “strongly support” the proposed upgrade of sports floodlighting.

Additional comments from respondents offered general support for the proposed upgrade and noted the benefits of better lighting for playing sport.

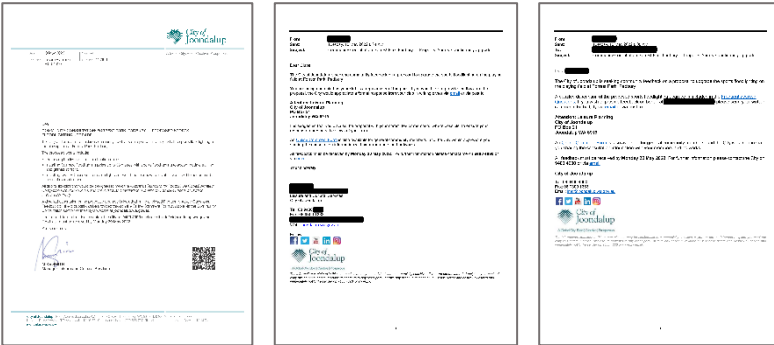

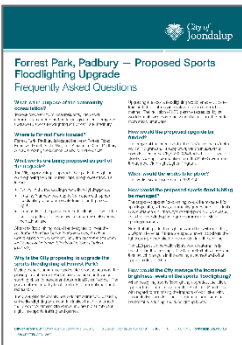

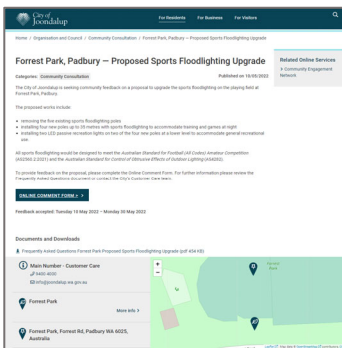

# RESPONSE RATE

The City collected a total of 111 valid responses throughout the 21-day advertised consultation period. Responses that were considered valid include all those which contained contact details enabling identification and were submitted within the advertised timeframe.

Of the 340 residents/landowners within 200 metres of Forrest Park, 13 submitted feedback. A further 95 community members who were not directly engaged also submitted feedback.

In relation to the park user groups, 3 written submissions were received from the following sporting clubs:

- Northern Warriors Veterans Football Club
- Joondalup United Football Club
- Whitford Amateur Football Club.

(Note that an analysis of these stakeholder responses has not been included in this report. Full verbatim responses are provided at Appendix 14–16).

The overall response rate was 4.6% from stakeholders who were engaged directly by the City. The majority of responses came from community member who were engaged indirectly. This data is shown in the table below.

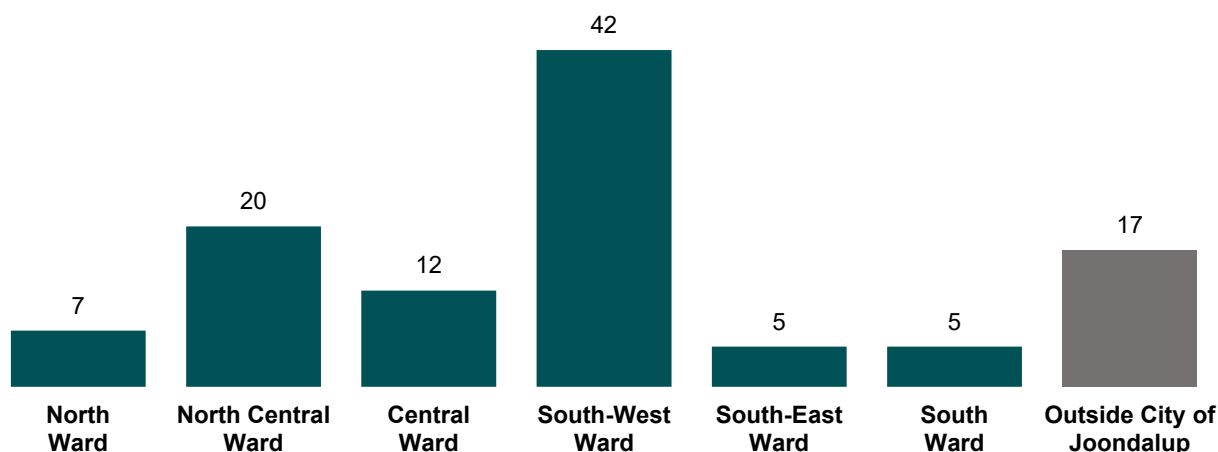

Responses received by ward:



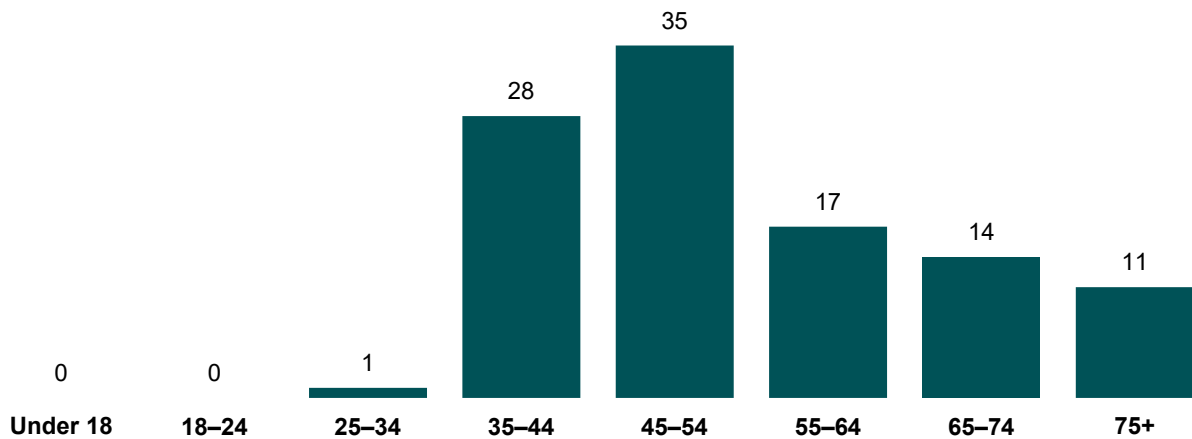

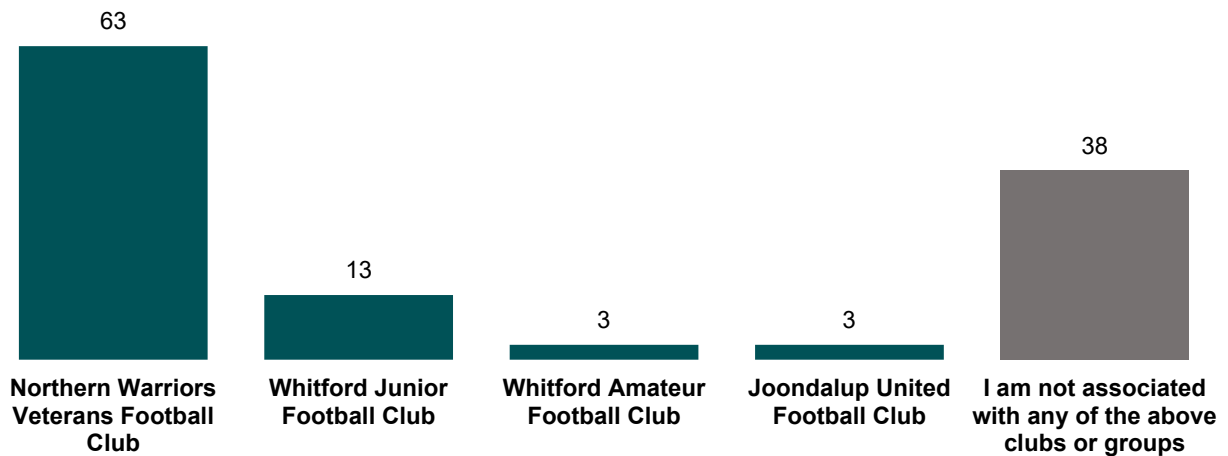

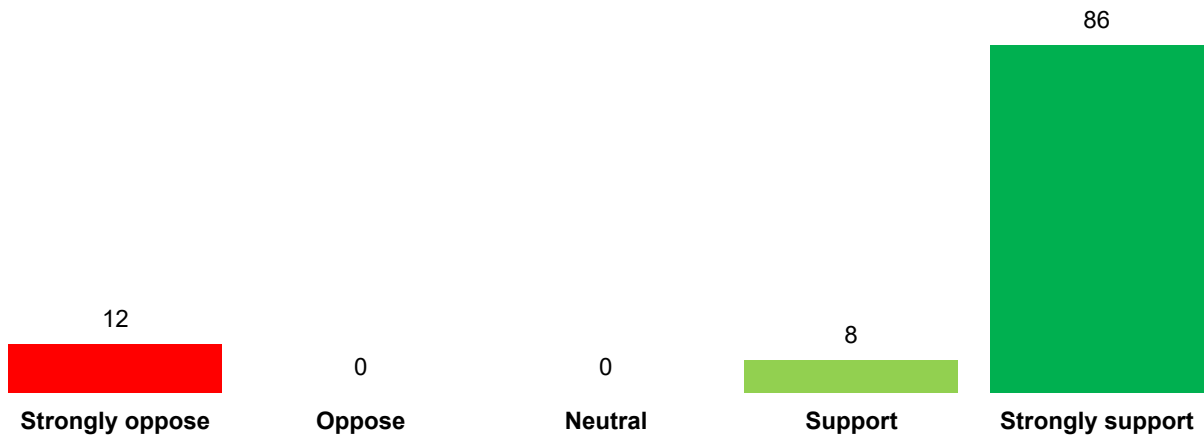

Respondents were asked if they have any comments about the proposed sports floodlighting upgrade at Forrest Park. A total of 96 respondents provided comments. These have been broadly summarised in the table below. Common themes included general support for the upgrade (24), and comments noting the benefits of better lighting for playing sport (32). Verbatim comments have been randomised and are provided at Appendix 17.

#### What is the purpose of the community consultation?

To seek feedback from local residents, interested community members and park user groups on a proposed upgrade to sports floodlighting at Forrest Park, Padbury.

#### Where is Forrest Park located?

Forrest Park, Padbury is located between Forrest Road, Bannister Road, Austin Way and Alexander Road, Padbury. A map showing the location can be found overleaf.

#### What works are being proposed as part of the upgrade?

The City is proposing to upgrade the sports floodlighting on the playing field at Forrest Park. The proposed works include:

- Removing the five existing sports floodlighting poles.
- Installing four new poles up to 35 metres with sports floodlighting to accommodate training and games at night.
- Installing two LED passive recreation lights on two of the four new poles at a lower level to accommodate general recreational use.

All sports floodlighting would be designed to meet the *Australian Standard for Football (All Codes) Amateur Competition (AS2560.2.2021)* and the *Australian Standard for Control of Obtrusive Effects of Outdoor Lighting (AS4282)*.

#### Why is the City proposing to upgrade the sports floodlighting at Forrest Park?

During the regular summer and winter sporting seasons, the playing field at Forrest Park is used by junior and senior sporting clubs for soccer and Australian Rules Football. The park is also utilised by local residents for casual sport and recreation.

The playing field currently has older infrastructure consisting of five floodlighting poles and luminaires that do not meet the relevant Australian Standards and are not suitable for night time sports training and games.

Upgrading the sports floodlighting would enable clubs to train and play matches in a safe and more accessible manner. The inclusion of LED passive recreation lights would enable local community members to use the park more safely after dark.

#### How would the proposed upgrade be funded?

The proposal has been listed in the City's Five-Year Capital Works Program and, if supported, will be included for consideration in the City's 2023/24 budget. The City would also be seeking a contribution from the State Government through the Club Night Lights Program.

#### When would the works take place?

The works would take place in 2023/24.

#### How would the proposed sports floodlighting be managed?

The proposed sports floodlighting would be managed for sporting clubs, schools, community groups and individuals in accordance with the City's existing park hire processes, as is the case during the regular summer and winter sporting seasons.

Note that all sports floodlighting would be switched off by 9.30pm. However, if there are special event bookings, the lighting may be required to be on later into the evening.

The LED passive recreation lights would automatically switch on in the morning at 5.30am and off at sunrise, and then switch on again in the evening at sunset and off at approximately 9.30pm.

#### How would the City manage the increased brightness levels of the sports floodlighting?

When designing sports floodlighting upgrades, the City's approach is to meet or exceed the Australian Standards with regard to minimising the impacts of obtrusive light. This includes consideration of design features, such as horizontal positioning and floodlighting types.



The new, taller poles would allow the luminaires to be aimed more directly onto the main playing areas, thereby reducing light spill onto nearby roads and residences. In circumstances where amenity issues are identified, increased design features would be employed to minimise potential adverse effects.

Similar sports floodlighting has been installed at Admiral Park, Heathridge; MacDonald Park (North), Padbury; Ocean Reef Park, Ocean Reef; and Warrandyte Park, Craigie.



Geared Construction Pty Ltd commenced work in February and has so far completed the site preparation and additional parking bays on Trappers Drive, Standish Way and Landor Gardens.

This redevelopment includes the construction of a new Community Sporting Facility that will better meet the needs of the park's 1,300 registered users and members of the local community.

Construction is expected to be completed in early 2023.

**Northern Warriors AFL Masters Football Club (NWFC)** has a 22-year tenancy history at Forrest Park and have worked with CoJ on many upgrades of the facility and grounds over this time. Our club is delighted to see the proposition for improved lighting reach the "community comment" stage. We believe the upgrade has benefits for all users of Forrest Park.

NWFC is the largest AFL Masters Club in Australia, with over 92% of our member's residents of the City of Joondalup.

Our current membership comprises 140+ playing and 40 nonplaying members and social members of a further 200. The club has experienced player growth of 15%, and has continued at a strong rate in seasons 2021 and 2022

Northern Warriors utilise the Forrest Park and the Community Sports Centre fifty weeks of the year for training and social functions each Monday and Wednesday evening from 5 to 9 pm.

The existing light towers on the oval were installed in a joint project between the City of Joondalup and NWVFC when the football club relocated from MacDonalds Reserve to Forrest Park in 1999. Even with a CoJ upgrade of the north side towers the existing illumination remains poor in that the playing area illumination is restricted and patchy. The current lighting towers on the South-side are too low and illumination on the oval is badly affected by tree branches. This patchy lighting raises ongoing safety concerns to us for our playing members and restricts the quality of training we can conduct on the ground in the evenings.

The proposed upgrade and the reduction in the number of lighting towers will provide increased engagement by players and a safer training environment.

We describe ourselves as a community club that plays AFL football. Our club has recently received a National Award from the Australian Football League which centred on mature aged men's health and wellbeing. We believe that with an upgrade of the lighting quality, football can be safely demonstrated and played by residents over 33-year-olds seeking to improve their fitness and quality of life in safety.

Northern Warriors AFL Masters Football Club supports a range of local and community groups and over the years has contributed over \$100,000 to groups such as Grandparents Rearing Grandchildren, Cancer Foundation through Relay For Life, Movember and Keep Your Feet and Women's Refuges

The generic growth of men's football and the amazing growth in women's football has placed pressure on training and playing parks and facility space across the City of Joondalup.

NWVFC and the other three regular hiring clubs recognise the expansion and appropriate illumination of Forrest Park as one solution to this existing and future problem.

We understand that WJFC, WAFC and JUFC will also submit supporting letters for this lighting upgrade at Forrest Park. We work closely with all three clubs, and we expect many of the local community users of Forrest Park will also benefit from the lighting upgrade. We coexist with many residents who regularly exercise and walk dogs at Forrest Park and understand that the proposed lighting full strength when the park is used for training or playing and will be able to be adjusted to a lower level suitable for exercise or walking dogs after dark as not to be intrusive beyond the park boundaries.

**Summary:**

Northern Warriors AFL Masters FC strongly supports the lighting upgrade at Forrest Park.

Our club see this upgrade as further enhancing benefits to and for existing and new members and promote our 22-year-old relationship with our local community.

We contribute to the health and wellbeing of mature aged men and see ourselves as a good community club that supports both our members and the broader community.

We see this as a great community project that benefits all users of the Forrest Park.

## COMMUNITY CONSULTATION: LIGHTING UPGRADE FORREST PARK

ATTENTION: [REDACTED]

**Whitfords Junior Football Club (WJFC)** have a current membership of 1,147 making the club one of the largest in Western Australia. More than 85% of registered players reside within the boundaries of the City of Joondalup. The growth of numbers in the past 5 years has predictive modelling expecting WJFC to exceed 1,200 players in 2023 with limited grounds and amenities to accommodate this number. However, WJFC are still utilising the same number of grounds and ground sizes as we were when we had less than 500 players and our aim is for our growth to be supported and assisted by the City of Joondalup with 2 upgrades to Forrest Park.

### LIGHTING UPGRADE

The introduction of Women's Football has created additional demand for grounds, lights and amenities to cater for young girls and teenage females as well as our very large number of males already playing. Female numbers have grown exponentially in the past 4 years and will continue to grow making Forrest Park at its current size configuration and poor lighting inadequate.

The lighting upgrade, to WA Football Commission standards, would allow for evening use catering to the demand for 100 lux lights as a result of the tremendous growth in male and female football across the Northern Conference. Currently Macdonald Park North is the only ground available to WJFC with the 100 lux lights required to meet the WA Football Commission standard for hosting night fixtures.

All Junior female football is played on Friday nights however, unlike netball there are very limited locations for playing within the City of Joondalup. Early fixtures at 4pm make life extremely difficult for parents to get children from school, changed, organised and ready to play half an hour later. Fading light in the middle of winter means games are not viable after 5.30pm.

### OVAL EXTENSION

WJFC senior boy's games cannot be scheduled at Forrest Park as the oval does not meet the size requirements set by the Western Australian Football Commission for Open Rules football. This restricts and excludes the older age groups from enjoying fixtures at Forrest Park Oval on weekends; currently affecting more than 12 home teams. This forces WJFC's Open Rules football fixtures to be accommodated at Macdonald Reserve North where there are already issues resulting from the shared use of the grounds with Whitford Amateur Football Club and West Perth Women's teams.

Further compounding the issues at Macdonald Reserve South is the potential for damage to the turf wicket where WJFC have been prohibited from playing a full winter season of games.

More than 45% of Junior male and female teams cannot currently play AFL at Forrest Park.

The existing playing area is used for training and playing both mid-week and over weekends for only Modified Rules football; children aged 7/8 - 11/12 years old. The small size of the oval also limits the number of children able to train at the ground. Expansion of Forrest Park would cater to games for children aged 7-18 years; effectively providing another full-size ground for the majority of players at WJFC. Any expansion of the size of the ground would alleviate training grounds pressure currently being experienced at Macdonald Park, Belrose, Otago, Mawson and Newcombe Park, allowing for another 50 younger children to train daily.

Further to WJFC's concerns if pressure was alleviated at Macdonald Park the benefits would flow on to the parking issues pertinent to another main tenant in the Joondalup Bridge Club. With parking spaces at a premium WJFC have regularly had to assist seniors at the facility with finding parking space, navigating across a wet, dark oval at night or assisting reversing their vehicles out amongst often 80 plus parents and players at Macdonald Park.

In a joint venture and agreement between the City of Joondalup, NWWFC and WJFC the clubs will meet the cost of shifting the existing goal posts, to increase the size of the playing area to cater to all teams over the age of 12 years.

**Summary:**

1. The current lighting, in terms of the age, quality and positioning is poor and doesn't allow for night fixtures at Forrest Reserve.
2. A lighting upgrade would enable WJFC to further expand and continue to be a destination club for families within the City of Joondalup.
3. A lighting upgrade and oval expansion would allow the Western Australian Football Commission to schedule fixtures at Forrest Reserve for all age groups. Enhancing the promotion of community fitness, physical and emotional health and wellbeing. Our aim is to avoid WJFC having to turn players away or transfer them to other clubs as a result of facilities that have failed to grow and accommodate WJFC's numbers.
4. The position and permanency of the Soccer Goals on the mid/eastern part of the playing field would be vastly improved through the realignment and extension process and no longer viewed as being a significant safety concern to Junior Footballers.

<i>The upgrade would make my life better.</i>
<i>Frankly can't see with the current lights. It would be great to see who I'm kicking too, so I don't cop so much off the other boys.</i>
<i>Excellent upgrade.</i>
<i>The existing lights are very weak and that makes training in the park dangerous.</i>
<i>This would greatly improve our ability to train at the ground at night.</i>
<i>I support this upgrade as long as it doesn't impact on the nearby residents.</i>
<i>Current lighting is substandard. This upgrade would assist the area to use this facility to its full potential.</i>
<i>Great idea. Lighting to suit sport and community activity after dark.</i>
<i>We have this lighting in [- - -] and so many sporting groups use them which is great. It keeps kids healthy and doing something constructive and great to see the fields being used so much more with the lighting.</i>
<i>We all speak about obesity in the children and in adults. Providing safe facilities for our children to play sport is of paramount. It is unfortunate that training needs to be late afternoon and stretching to night time. Good lighting is essential for groups to be able to play their sport with good lighting to see the ball, running and practicing on nets. Also we need to safeguard mothers, fathers and children who take their children to this park and wait for the children to finish practicing their sport.</i>
<i>If you wish the field to be used at night for sport then good lighting is essential.</i>
<i>Would be great for the community and clubs as they could play games at night.</i>
<i>Strongly support. The lights haven't been upgraded for a very long time and they are a need for night games, safety and security. It's a good thing for the community.</i>
<i>It will assist multiple sports to train safely.</i>
<i>Would be greatly appreciated by all who play for the [- - -].</i>
<i>I believe proposed lighting upgrade at Forrest Park will create a much safer, more appealing environment that the broader community will benefit from.</i>
<i>These lights will be way too bright and tall. The lights there now are bad enough, [- - -] have trouble sleeping. The noise level from this park when there is a game or training, especially at night, is unbearable.</i>

<i>I think it will be of great benefit to all that use the oval. The current lighting actually makes it difficult to see the ball coming at different spots of the oval and doesn't light the oval consistently.</i>
<i>I lived in the area for [ - - - ] while my house was being rebuilt in [ - - - ], the lights work just fine. There are parks around the City with no lights, such as MacNaughton Park. Why not put lights where they are needed rather than upgrading ones that already work?</i>
<i>Widening of the ground would also be great.</i>
<i>Anything to get people more interested in physical activity and community.</i>
<i>Any measures implemented that encourage or support sporting activities in children and adults is to be applauded. I would also like to see all-night lighting in public parks and also security cameras. People should be able to feel safe walking or playing sport in public parks at all times. Cameras would also prevent vandalism and crime. I fully support the upgrade of lighting at Forrest Park.</i>
<i>This will greatly improve the facility's ability to host night training, games and safety of all users.</i>
<i>I am a member of [ - - - ] and a regular trainer. The old lights have many shadows, dark spots on the ground and I regularly trip in wild weather. The two newer lights on the northern side far out-perform the three older lights on the southern side. New lights will be a welcome addition to our awesome club, but must also be a cost saving for the CoJ. [ - - - ]</i>
<i>Over the last few years the City of Joondalup has endeavoured to turn this small local park into a major sporting venue. I find it interesting that the eastern side of Marmion Avenue is the focus of such endeavours and am sure it reflects the lower SEIFA index in our area. I am beginning to loathe the very name of Joondalup! It is not, in my opinion, synonymous with community.</i>
<i>The last time we had a proposed modification to Forrest Park the proposal was flawed and rescinded after much effort from residents. This proposal is not as complex but I do query the motives behind such modifications. Does this mean we will be hearing and seeing an increase of usage, and with it, more noise? On some nights during training sessions, and during the day on match days, we hear a continuous barrage of obscene language emanating from the park.</i>
<i>I have trained under the lights and watched [ - - - ] play under them. They are not safe the way they are now. With growing number of [ - - - ] in the area getting involved in AFL, I think there is no choice but to upgrade. Safety first.</i>
<i>Both my [ - - - ] play for [ - - - ] and they [ - - - ] team too. With younger children obsessed with being online and older children (18+) out drinking in the evenings I think it is so important to keep sporting facilities updated. We need to do as much as we can to help promote sports in WA.</i>
<i>Any upgrade that supports all sports is a bonus.</i>
<i>The new lighting is much needed and welcomed. The [ - - - ] train [ - - - ] and the existing lights only cover limited parts of the ground. New lighting, which would cover the whole ground and increase visibility, is much needed — especially for [ - - - ] whose eyesight struggle in dim light to see the football.</i>
<i>Brilliant and so overdue.</i>
<i>Good quality lighting allows a safe environment for the community to use the oval facility.</i>
<i>Please ensure that large lights are on for games only and not wasting electricity by being on until late at night. It should be the responsibility of each club to advise the City of Joondalup when they require the lights to be on and for how long. But it should also be up to the City of Joondalup to make someone available to process requests within 24 hours, and not take a week to sort out, by being passed from department to department, especially as there are so many part-timers working within the City of Joondalup.</i>
<i>It will encourage increased patronage and make training at night safer by avoiding injuries.</i>
<i>There is sufficient lighting on nearby MacDonald Park. Any additional or late-night sports should use existing facilities to save unnecessary costs, particularly as it wasn't that long ago that the existing lights were installed.</i>
<i>Huge disappointment to hear that these floodlights are going up before [ - - - ] Park. The lights are [ - - - ] are in the worst state of functionality and are a danger to the public and community sporting groups using them. [ - - - ] have been let down by the Council over the years as the lights at [ - - - ] were due for replacement several years ago.</i>

<i>I train at Forrest Park [ - - ] and I strongly support the floodlighting upgrade. Currently the lighting is substandard, as it does not provide enough light to play night games or have safe, well-lit training.</i>
<i>We need them asap as the current lights are very poor.</i>

<i>New lights will make training so much better. Now, many areas are very dark, too dark for good training. Thanks.</i>
<i>Keeping youth interested in sports for as long as possible means that they have less opportunities to fall into anti-social and peer group pressure.</i>
<i>Very important that the lights don't disturb the people in surrounding areas or cast bright pools of light onto roads. Also, it is extremely important that the angle of the lighting cannot dazzle drivers on any of the roads.</i>
<i>Absolutely necessary. The current dark patches on the oval present a very real danger to members of our club as they train and play on the oval at night. Possible collisions could cause serious injury. Furthermore, the general public who are often walking dogs or other exercise in our vicinity, may not see a stray ball heading their way nor a player running into their path. I am also concerned for the wellbeing of the general public who use the oval, as better lighting will clearly provide a safer environment to be in.</i>
<i>I'm more interested in the passive recreational lights, but support both lighting options. Supporting this as will be good for Padbury area. Would like to see this extended to other locations, such as Moolanda Park, Kingsley.</i>
<i>As a member of [ - - ] as well the only issue from there was the ability to turn the lights on and off after pre-arranged times have run out, for special events or extended training nights/games.</i>
<i>Anything that encourages our youngsters to become involved in sport gets my support. Go for it.</i>
<i>The current lights are inadequate.</i>
<i>Fantastic proposal, a lot of AFL, soccer and other sports and dog walkers use that park. It helps with OSH with brighter lights, helps with safety of users and would encourage more people to exercise.</i>
<i>It's great for all clubs who use the park. It brings a safer environment for club users and helps cover the ever-increasing needs for sports grounds. The light upgrade creates the opportunity for night time AFL games to be played at Forrest Park. And the new lights will also support safe local community access for walking and dog walking and exercising. The lights are only on high while sport is on the ground and revert to "community lighting" which means limited impact on residents close to the ground. Our club has been a tenant at Forrest Park for over [ - - ] years and initiated the installation of [ - - ] lights and an upgrade [ - - ] with the City of Joondalup. The whole community benefited from this. The upgrade is strongly supported by our club. [ - - ]</i>
<i>Good lighting prevents injury.</i>
<i>Floodlight upgrade will be highly beneficial to the community.</i>
<i>Good upgrade to facilities.</i>
<i>It is a sensational initiative. There have been many a time where the existing lights have not provided sufficient lighting for night activities and exercises and members have been placed in dangerous predicaments. This lighting upgrade will ensure the safety of all people using the oval and facilities.</i>
<i>Last year a significant amount of funds were spent on upgrading lighting at MacDonald Oval at the [ - - ] request. Spending should be allocated to other areas of sport other than the [ - - ] request every year.</i>
<i>I imagine that the old lights are no longer serving their purpose and that these new lights will be more efficient and effective. I note that the lighting will be targeted to the playing field thereby reducing spill to nearby residences. If this is the case, I feel this would be an improvement on old ones. I am not sure how tall the old lights are — this would have been a useful inclusion in the reference material. I trust the height of these new poles will not be a problem for residents nearby.</i>
<i>Yes please! The sooner the better. My eyeballs aren't what they used to be, getting hard to stop the ball smacking into the bonce!</i>

<p>My [ - - ] and I have already rejected a previous proposal for the park to become a club ground due to the noise and lighting issues. The current training at night is very noisy both on field and off when the players gather for drinks afterwards. Improving the lighting will only lead to an increase in the noise levels and the nuisance lighting that the locals have to endure. This was public open space to be used by the residents for the residents not for sporting clubs in outer areas. Instead of an online comment form why not visit the area when training is on and ask the residents for their opinion.</p>
<p>Better lighting as there are a few dead spots on the ground where it's difficult to see the ball.</p>
<p>Sports and clubs like the [ - - ] offer a great support network for men and families who may be struggling with external pressures. Lights will allow to club to extend training times and attract more players to join the club. A great initiative to get more fathers active. Hopefully this gets through.</p>
<p>Any proposal that enhances and/or encourages sporting activities is an asset to the community. Will be well utilised.</p>
<p>Adverse effects of floodlighting on the environment and residents are to be expected and are not desirable. This is already the case at MacDonald Park which is in the immediate vicinity. Minimising effects of obtrusive light is extremely important. New energy efficient lighting should only be installed if adverse effects are less than caused by the current lighting. If that is not possible, new floodlights should not be installed.</p>
<p>New lights are long overdue. Many sports groups and walkers/exercise groups use the ground.</p>
<p>This enhances night training sessions which gives all players who use the facility a good chance for skill enhancement and sport enjoyment.</p>
<p>I think it is a great idea.</p>

<p>This upgrade will prevent [ - - ] getting hit by footballs they can't see. Thanks.</p>
<p>I believed the park was for leisure for all the local community to use rather than a predominantly sports leisure ground requiring ever more advanced lighting and limited parking facilities. It is also closely surrounded on three sides by housing with residents, most of whom I would imagine would not appreciate organised matches being played possibly up until 9.30 pm. The higher lighting would also surely dominate the pleasant surroundings of this lovely area with a park of somewhat limited dimensions.</p>

<i>To get maximum usage out of the ground, six light poles would be better and also, slight change of direction of the football goal posts to make the oval longer would make the playing surface even better.</i>
