Notes to the Application to Register a Corporate Nominee

1	When to use this form	The Corporate Body may make a claim to register nominees using this form at any time. However if the Corporate Body wants to be represented on the roll for a particular election it must give its claim form to the City of Joondalup more than 50 days before the election date.
2	Who should use	You should fill in this form if the Corporate Body:
	this form	• owns or occupies ³ rateable property in the City of Joondalup and the nominees are not on the residents roll for the City of or Joondalup;
		 qualify under Clause 12 of Schedule 9.3 of the Local Government Act 1995⁷, and want to be able to vote at City of Joondalup elections.
		It should be noted that the Corporate Body may nominate two persons who are on either the State or Commonwealth Electoral Roll, to enrol, as electors. If a proposed nominee is on the residents roll for the City of Joondalup, they are automatically enrolled to vote.
3	Who is an occupier	To qualify as an occupier the Corporate Body must have a right, under a lease, tenancy agreement or other legal instrument, to be in continuous occupation of the property for at least the next 3 months.
