OVERVIEW

The community was invited to provide feedback from 3 April 2018 to 2 May 2018 on a proposal to upgrade the sports floodlighting at Windermere Park, Joondalup to meet the *Australian Standards for Football (All Codes) Amateur Competition (AS25060.2.3)* and the *Control of Obtrusive Effects of Outdoor Lighting (AS4282)*.

Feedback was sought by way of a Comment Form to determine the overall level of community support for the proposal.

The City collected a total of 12 valid responses throughout the 29-day advertised engagement period. 10 of these came from stakeholders who had been *directly* engaged by the City, indicating a response rate of 3.5%. These included responses from representatives of the 4 park user groups:

- Joondalup Kinross Junior Football Club
- Joondalup Kinross Cricket Club and Joondalup Kinross Junior Cricket Club (joint response)
- ECU Jets Amateur Football Club

Respondents were asked to indicate their overall level of support for upgrading the sports floodlighting on a five-point scale from “strongly support” to “strongly oppose”. 10 respondents indicated that they either “support” or “strongly support” the proposal, with 9 respondents indicating *strong* support.

The 2 respondents who opposed the proposal stated their primary concerns as being the cost of floodlighting to the City and ratepayers, and the potential for light pollution into nearby homes. Additional comments from other respondents included the belief that floodlighting upgrades support local clubs and families, and requests that the City ensure the floodlighting is switched off by 9.30 pm.

STAKEHOLDERS

A total of 288 stakeholders were *directly* engaged by the City. Stakeholders identified included:

- Local residents and landowners within a 200 metres radius of Windermere Park = 284
- Park user groups = 4:
 - Joondalup Kinross Junior Football Club
 - Joondalup Kinross Cricket Club
 - Joondalup Kinross Junior Cricket Club
 - ECU Jets Amateur Football Club

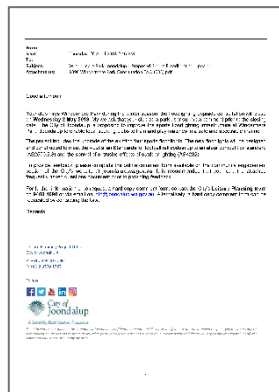
Additional stakeholders, including park visitors and interested residents and landowners living further than 200 metres away from the park, were also *indirectly* engaged by the City via the engagement materials described below.

ENGAGEMENT MATERIALS

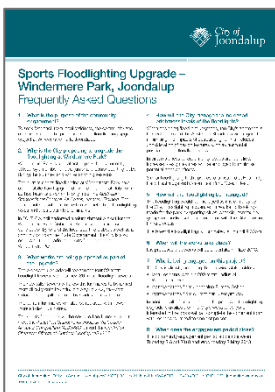
Local residents and landowners within a 200 metres radius of Windermere Park were sent information packs through the post containing a cover letter and Frequently Asked Questions document. These stakeholders were directed via the cover letter to the City's website to complete the online Comment Form. They were also advised that hard-copy Comment Forms were available on request.

The 4 park user groups were telephoned by City staff advising them of the engagement and directing them to the City's website to complete the online Comment Form. These stakeholders were also sent a reminder follow-up email directing them to the City's website.

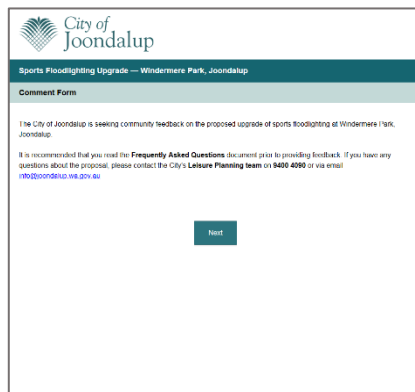
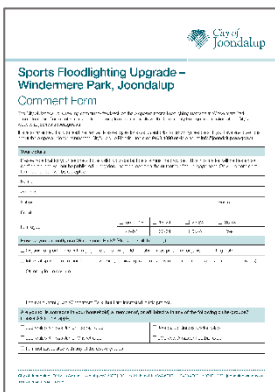

RESPONSE RATE

The City collected a total of 12 valid responses throughout the 29-day advertised engagement period. Responses that were considered valid include all those which contained contact details enabling identification, and were submitted within the advertised engagement period. Where multiple Comment Forms were received from the same respondent these were combined into one response.

Of the 12 respondents, all completed the Comment Form online. Further, a representative of all of the Windermere Park user groups provided feedback, including:

- Joondalup Kinross Junior Football Club
- Joondalup Kinross Cricket Club and Joondalup Kinross Junior Cricket Club (joint response)
- ECU Jets Amateur Football Club

Of the 284 residents and landowners within a 200 metres radius of Windermere Park, 7 submitted feedback. An additional 2 community members, who were not directly engaged, also submitted feedback. These data are shown in the tables below.

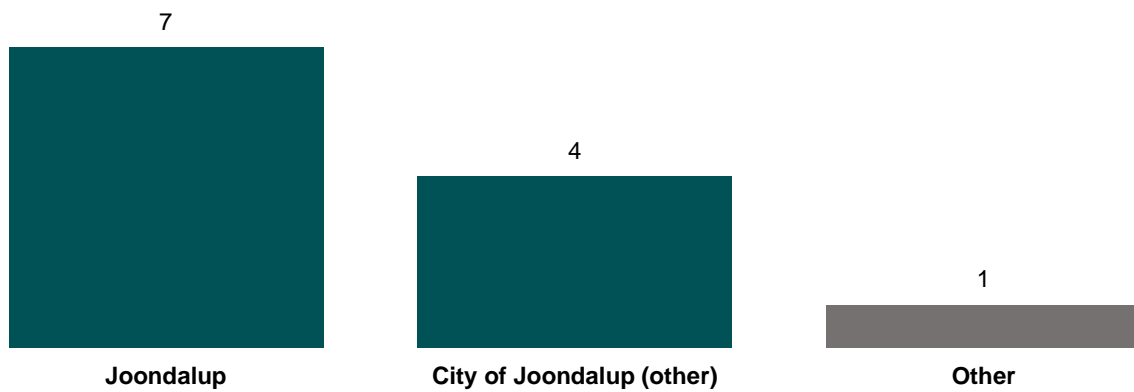
DEMOGRAPHICS

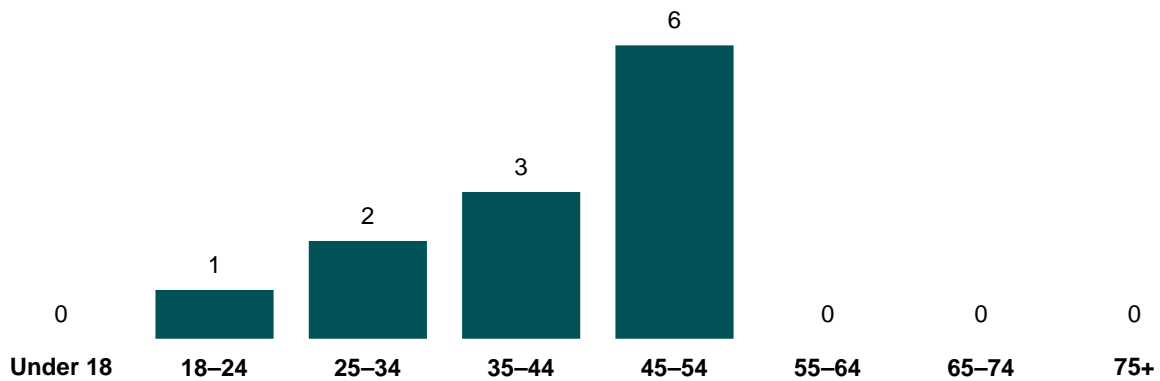


Respondent age

Respondents were asked how they used Windermere Park with the following options:

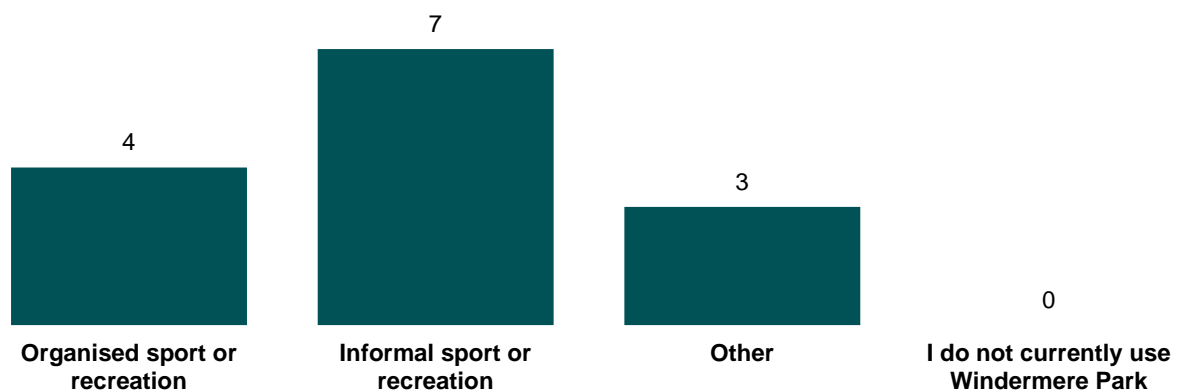
- Organised sport or recreation (eg hire the playing field or clubroom as part of an organised sporting club)

Responses received by type of park use:



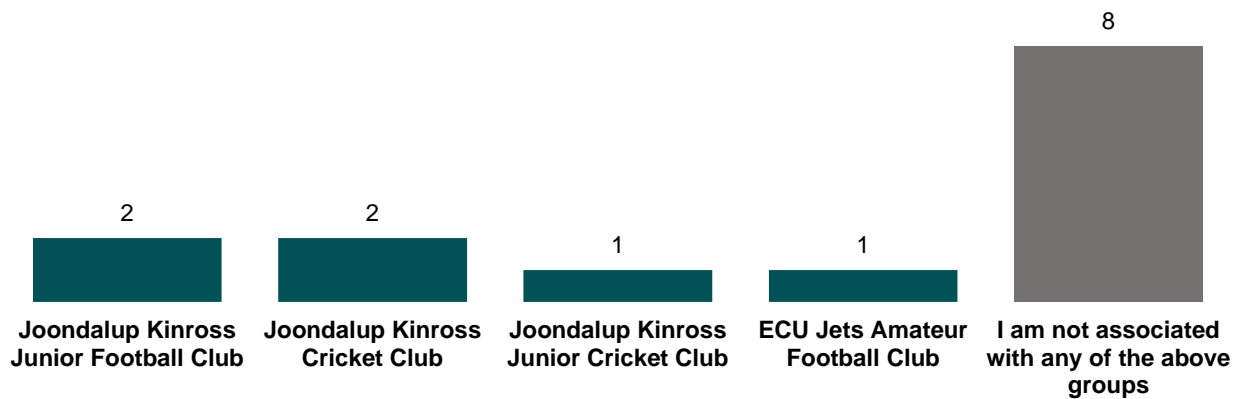

Responses received by membership/affiliation to park user groups:



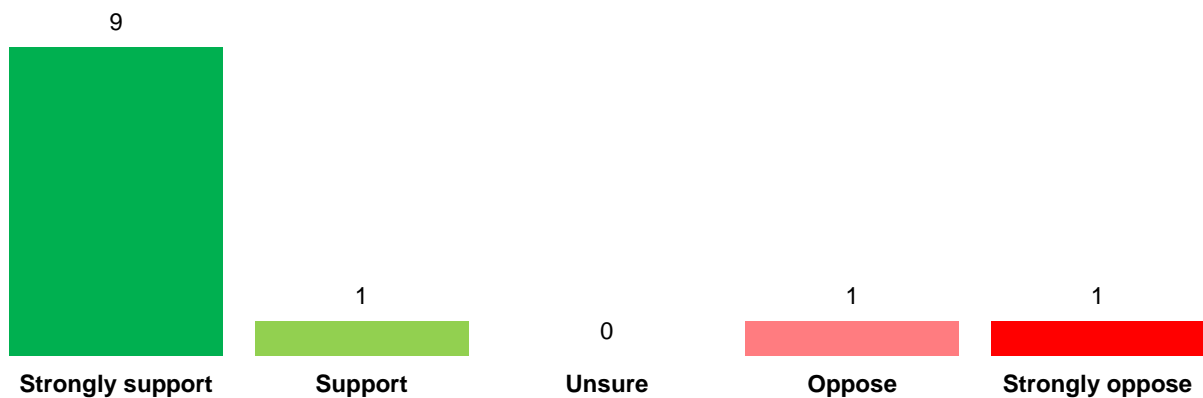
COMMENT FORM QUESTIONS

QUESTION: “The City is proposing to upgrade the sports floodlighting at Windermere Park, Joondalup to meet the *Australian Standards for Football (All Codes) Amateur Competition (AS25060.2.3)* and the *Control of Obtrusive Effects of Outdoor Lighting (AS4282)*. Please indicate your level of support for this proposal.”

Respondents were asked to indicate their level of support for upgrading the floodlighting at Windermere Park on a five-point scale from “strongly support” to “strongly oppose”. The majority of respondents (10) indicated that they either “support” or “strongly support” the proposal. 2 respondents indicated that they were either “opposed” or “strongly opposed”. These data are shown in the table and chart below.

QUESTION: “If you oppose the upgrade of the sports floodlighting at Windermere Park, please explain why”

Respondents who “oppose” or “strongly oppose” the upgrading of floodlighting at Windermere Park were asked to explain why. There were 2 respondents who provided feedback and their primary concerns included: the cost of floodlighting to the City and ratepayers, and the potential for light pollution into nearby homes. Verbatim comments have been randomised and are provided in the table below.

Verbatim responses* — If you oppose the upgrade of the sports floodlighting at Windermere Park, please explain why (N = 3):
<i>From viewing the park, the current lights appear sufficient. The park is lit enough for sporting to occur with no issues. The current lights are not obtrusive to the houses surrounding the park as they are enclosed by the trees circling the park so that the light is mostly contained to the park. If the lights are increased to a height of 30m, they will sit above the level of the trees so that the light will extend beyond the park to neighbouring houses. Given that sporting activities take place in the park on most week nights until late in the evening, the height of the proposed lights, combined with modern LED lighting, will create a disturbance to neighbouring houses.</i>
<i>I disagree with the update of the floodlight update as they are working ok at the moment. Why fix something that isn't broken. There are not that many people over there at night once the football is over. You should be spending taxpayers' money on better things.</i>

QUESTION: “Do you have any (further) comments about the proposed upgrade to the sports floodlighting at Windermere Park?”

Respondents were asked if they had any (further) comments about the proposed upgrading of floodlighting at Windermere Park. 10 respondents provided feedback, common themes included:

- belief that floodlighting upgrades support local clubs and families
- concern about light pollution into nearby homes
- request that the City ensure the floodlighting is switched off by 9.30 pm
- belief that floodlighting upgrades are expensive and unnecessary

Verbatim comments have been randomised and are provided in the table below.

Verbatim responses* — Do you have any (further) comments about the proposed upgrade to the sports floodlighting at Windermere Park (N = 10):
<i>It's a great idea — supports local sport clubs.</i>
<i>The Joondalup Kinross Cricket Club (Junior and Senior divisions) fully supports the upgrade of the lighting at Windemere Park and look forward to utilising the lights to enhance our training programs and increase the participation of our members and their families.</i>
<i>You're wasting my hard-earned money on hairbrained ideas to keep the football and cricket players happy and made the park a lead on dogs park. Most people stay away from the park now because of it. Just to keep your footy and cricket mates happy. Everyone who takes their dogs over there knows it should bring back bulk collection. You give people a tiny skip to put their rubbish in and expect people to make do. Most of you people in the Council don't know what you are doing. You couldn't organise a [- - -].</i>
<i>As I live [- - -] from the park and current lighting directly impacts my [- - -] please ensure new lights deliver on reducing the lateral light impacts to current as per outlined on FAQ sheet. Also, please ensure lights are automatically switched off at 9.30 pm, so impacts on residents, such as myself, are minimised. Not having the lights switched off automatically encourages people to hang around the park causing disturbances to the neighbours.</i>
<i>Will be very beneficial for the ECU Jets Sports Club. We use the ground for AFL and can now have later fixtures, avoiding congestion with the Junior Football club and its growth. We are planning on having two teams in the very near future so this will assist us a lot.</i>
<i>Please just do it. It needs an update. Would be great to see at least one of the lighting plants on during each evening too...</i>
<i>This is a fantastic opportunity to improve the current lighting standards at Windermere Park to allow participants of all ages the opportunity to enjoy playing AFL under lights in a safe and fun environment. It will also provide a safer training venue with the higher towers that will provide more direct and concentrated lighting of the playing surface. Working in the infrastructure industry, I'm also aware that the proposed luminaries will significantly reduce any lighting spill onto nearby roads and residencies.</i>
<i>Happy for upgraded floodlighting to go ahead if it does reduce current light spill onto my property as stated on the Frequently Asked Questions form. Also, the latest time being 9.30 pm for training, as the noise tends to carry some distance.</i>
<i>A welcome upgrade.</i>
<i>Absolutely love the idea of the upgrade. I would add, if possible, to install one of those outside GYMs so some of the public can exercise on the outdoor Gym. I strongly believe many will find it very useful and inviting for the continuation of improving the public's health with easy access to the outdoor Gym.</i>

Sports Floodlighting Upgrade – Windermere Park, Joondalup Frequently Asked Questions

1. What is the purpose of the community engagement?

To seek feedback from local residents, the community and park users about the proposed sports floodlighting upgrade project at Windermere Park, Joondalup.

2. Why is the City proposing to upgrade the floodlighting at Windermere Park?

Windermere Park is a local active park that is currently utilised by a number of local junior and senior sporting clubs during the summer and winter sporting seasons.

The current sports floodlighting at Windermere Park have been installed and upgraded by one of the local clubs on an ad hoc basis and currently only meet the *Australian Standards for Football (All Codes) Amateur Training*. The current infrastructure is based on 20 metre high floodlighting poles and uses older style luminaires.

In 2017, Council endorsed a refurbishment project for the Windermere Park Clubroom. As a result of a financial contribution by one of the local sporting clubs, as well as a contribution from the State Government, the City is also proposing to upgrade the sports floodlighting at Windermere Park.

3. What works are being proposed as part of the upgrade?

The proposed upgrade will replace the four 20 metre floodlight towers with four new 30 metre floodlight towers.

The new taller towers will allow the luminaires to be aimed more directly onto the principle playing area, therefore reducing light spill onto nearby roads and residences.

The current luminaires will also be replaced with newer more efficient luminaires.

The sports floodlights will be designed and constructed to meet the *Australian Standard for Football (All Codes) Amateur Competition (AS2560.2.3)* and the *Control of Obtrusive Effects of Outdoor Lighting (AS4282)*.

4. How will the City manage the increased brightness levels of the floodlights?

When designing floodlight upgrades, the City's approach is to meet or exceed the Australian Standards with regard to minimising the impacts of obtrusive light. This includes consideration of design features such as horizontal positioning and floodlight types.

In circumstances where amenity issues are identified, increased design features will be employed to minimise potential adverse effects.

Similar floodlighting to the proposed is installed at Heathridge Park, Heathridge and Ocean Reef Park, Ocean Reef.

5. How will the floodlighting be managed?

The floodlighting would be managed as it is currently by the City. Floodlighting is operated in relation to bookings made for the park by sporting clubs, schools, community groups and individuals in accordance with the City's existing hiring process.

The latest the floodlighting is illuminated is up until 9.30pm.

6. When will the works take place?

It is proposed that works will be undertaken in late 2018.

7. Who is being engaged on this project?

The City is directly engaging the following stakeholders:

- local residents within a 200 metre radius of Windermere Park;
- representatives from Joondalup Primary School;
- representatives from current park user groups.

In addition, all information about the proposed floodlighting upgrade is available on the City's website. Anyone interested in the proposal can complete the comment form with responses limited to one per person.

8. When does the engagement period close?

The community engagement period is open between **Tuesday 3 April 2018** and **Wednesday 2 May 2018**.
