

Changes to Joondalup City Centre Resident and Visitor Parking Permits

Frequently Asked Questions

At its July 2018 meeting, the City of Joondalup Council endorsed changes to the issue and use of Resident and Visitor Parking Permits.

From the start of the 2019 calendar year, the current maximum of five free permits for residents living in the Joondalup City Centre will be reduced to a maximum of three free and one purchased permit issued to each property until the end of the 2022 calendar year.

Why is the City changing how the current parking permits are allocated to residents?

The Joondalup City Centre has grown into a successful, highly liveable and vibrant civic and cultural destination, resulting in increased demand for parking by people who live, work and visit Joondalup.

The City has sought to address concerns raised by residents and business owners that the number of Resident and Visitor Parking Permits issued since the City introduced permits in 2009 is far exceeding the number of parking spaces currently available.

As a result, excessive levels of on-street parking by permit holders has impacted on the availability of parking for people visiting homes and businesses in the Joondalup City Centre.

What do the changes include?

The two different types of permits – Resident Parking Permit and Visitor Parking Permit – will be replaced with a single type Annual Parking Permit.

Residents who live in City Centre Resident Parking Permit areas can apply for a maximum of up to:

- Three free permits with one extra available to be purchased (from 2019-2022)
- Two free permits with one extra available to be purchased (from 2023-2027)
- Two free permits with no extra purchased permits available (from 2028 onwards)

What area do the changes apply to?

The changes will apply to Resident/Visitor Parking Permit Areas in Joondalup City North, east of Lakeside Drive and to the south of the Edith Cowan University Campus and Joondalup Police Academy.

When do the changes take effect?

The first set of changes will come into effect from 1 January 2019.

Am I entitled to free Annual Parking Permits?

From 2019 to 2022, residents who live in City Centre Resident Parking Permit areas will be entitled to three free permits. This will decrease to two free permits from 2023 onwards.

Can I purchase additional Annual Parking Permits?

From 2019 to 2027, residents can purchase a maximum of one permit per property. From 2028 onwards, no additional permits can be purchased.

How much will it cost to purchase an additional Annual Parking Permit?

A fee of \$100.00 will be charged for the issue of an additional permit. Permits will expire on 31 December, in the year of issue.

Can I purchase Annual Parking Permit if I am not a resident?

Property managers and tradespeople who require regular access to managed properties within permit parking areas, may apply in writing identifying the circumstances which require them to purchase a permit.

If approved, these permits will incur a fee for each permit area and may be limited to one permit per organisation each calendar year.

A new application to purchase a permit is required to be submitted each year as renewal notices will not be issued for these permits.

Where can my visitors/customers park if they do not have an Annual Parking Permit?

The City provides short term parking bays within resident permit parking areas, where permits are not required to be displayed.

These bays ensure that convenient parking is still available for visitors during permit parking times and days (i.e. 9.00am to 5.00pm on weekdays excluding Public Holidays).
