All hirers will be required to complete their own specific COVID-19 Safety Plan that addresses their management strategies to ensure adherence to hygiene standard requirements, including the provision and supply of cleaning equipment and consumables. This plan must include sanitisation of high contact areas and shared equipment before they commence and after they conclude their activity.

Hygiene standards and requirements may be reassessed in line with the changing risk profile associated with COVID-19.
