

LiveLighter Picnic Pack Competition Terms and Conditions

These terms and conditions govern the competition. All other information provided prior to entering the competition, including any instructions on how to enter the competition, form part of these terms and conditions. Participation in this competition is deemed acceptance of these terms and conditions. Any entry not complying with these terms and conditions is invalid.

Who Can Enter

- 1. Entry is only open to residents of Western Australia, eighteen (18) years and over who share the Facebook post for the Music in the Park November Concert to be held at Penistone Park, Greenwood.
- 2. Employees (and their immediate families) of the promoter and agencies associated with this competition are ineligible to enter.
