Pensioner concessions can only be applied on the production of a current Pensioner Concession Card (issued by Centrelink or Department of Veterans Affairs), State Concession Card, or a Senior's Card together with a Commonwealth Senior's Health Card.

Please note gold, white and orange veteran cards are not eligible for pensioner concessions.
