

# **Community Art Exhibition 2023**

### **Frequently Asked Questions**

### When are entries open?

Entries open 12pm, **Monday 12 December 2022** and close 12pm, **Monday 13 February 2023** (or upon receipt of 200 entries).

### Who is eligible to enter?

Artists must be a resident of the City of Joondalup (the City) or a current member of an incorporated not-for-profit visual arts association located within the City.

High school students aged 12 years and over are eligible to enter and must be enrolled in a secondary school in the City on **Sunday 19 March 2023**.

Employees of the City of Joondalup are eligible to enter but only to exhibit and will not be considered for any of the prizes.

### How much is it to enter?

Standard entry is \$30.00 and student entry is \$10.00. There is no concession rate and refunds.

### How do I enter?

Artists are required to complete an online entry form on the <u>City of Joondalup Community Art Exhibition</u> <u>website</u> that requests contact information, artwork information, an image of the artwork and optional award information.

Hard copy forms are not accepted, however artists can request assistance to complete the entry form by contacting the City's Visual Arts team on **visualarts@joondalup.wa.gov.au** or **9400 4000**.

For those that cannot make an online payment, the City will still accept direct payment through the City's Customer Service team at the Administration Building, 90 Boas Avenue, Joondalup during opening hours of Monday – Friday, 8.30am – 4.30pm.

### How do I pay the entry fee?

At the end of the online entry form, artists are required to pay the entry fee using a credit card. Alternately, artists can pay using cash, eftpos or credit card at the City's Administration Building during opening hours – please contact the City's Visual Arts Team to request this.

### Where and when is the exhibition?

The exhibition is held in the Great Space at Lakeside Joondalup Shopping Centre, 420 Joondalup Drive. Artworks are viewable to the public from **Monday 20 March – Saturday 15 April 2023** during centre opening hours.

Monday – Friday, 8.30am – 9.00pm Saturday, 8.30am – 5.00pm Sunday, 10.30am – 5.00pm

# Where and when do I need to deliver and collect my artwork?

All artworks are required to be delivered to the Great Space in Lakeside Joondalup (the Venue) between 10.00am – 1.00pm, **Sunday 19 March 2023**.

Unsold artworks are required to be collected from the Venue by artists between 11.00am – 2.00pm, **Sunday 16 April 2023**. Uncollected artworks will become the property of the City and may be disposed of at the discretion of the City.

Artists are responsible for their own transit insurance and artwork packing, which they must take with them after delivery.

### When is the opening night and what does it entail? Can artists bring guests?

The City is currently planning for an opening night for all exhibiting artists, pending any government restrictions for gatherings that may come into effect. Currently all artists will be invited to attend the

Opening Night function **Saturday 25 March 2023**, 6.30 – 8.30pm at the venue. Artists may bring one (1) guest. Award winners will be announced at this function. Further event details will be sent in 2023 in the event invitation.

# What do I need to provide as an artist prior to artwork delivery?

Artists will receive instructions from the City's Visual Arts team in 2023 after the entry period closes, including the sending of an artwork delivery form that is required at delivery. Artists must have their artwork finished and ready for installation, including D-rings secured to artworks ready for hanging on lines and hooks – artworks with hanging wire will not be accepted.

### How will my artwork be installed?

2-D works will be displayed on exhibition walling with hanging lines and hooks as per the City's curation. Artists with particular requirements should contact the City.

Artists with installation requirements for power and 3-D works must contact the City to confirm equipment provision and risk assessment.

### Can I make changes to my artwork after it is installed?

No, once the artwork is received by the City further changes are not possible, including installation requests. Artists should contact the City in advance for any particular requirements.

### What are the sale details for artworks?

All artworks must be available for sale and within a price point of \$2,000. The City takes a 20% commission on all artworks sold, with the remaining 80% being received by the artists. The City processes the overall sales fee and contacts the artists in event of a sale to confirm invoicing details. Read the <u>Terms and</u> <u>Conditions</u> for further information.

### What would deem an artwork ineligible for inclusion in the exhibition?

All artworks must meet the Terms and Conditions. Should an artist breach these the City has the discretion to deem the artwork ineligible and exclude it from exhibition. This decision is final and not subject to appeals.

The artwork must be original, have not been exhibited

before and suitable for viewing by all ages.

#### Size restrictions

Artists must pay attention to the sizing restrictions for artworks:

- 2-D artworks must not exceed 100cm (H) x 100cm (W) (including frame);
- 3-D artworks must not exceed 100cm (H) x 100cm (W) x 100cm (D) (including base); and
- Artworks must not exceed 10kg in weight.

No more than a single artwork will be accepted, however a diptych or triptych is permitted as long as it fits within the overall size restrictions. Artists should contact the City's Visual Arts team for further advice if their artwork has multiple parts.

All artworks must be suitable for installation and display across the entire exhibition, that is artworks must be sturdy and not pose risk of damage to people or itself. Artwork deemed too fragile for display will not be included.

### **Cultural Protocols**

The City will not accept artworks that are culturally inappropriate. The following guidelines are available for artists to check their artwork is culturally appropriate.

<u>Australia Council for the Arts – First Nations Cultural</u> and Intellectual Property in the Arts

National Association for the Visual Arts (NAVA) has further information about cultural guidelines and artist responsibilities towards representation, cultural appropriation and stereotyping:

"Artists have responsibilities around representation, specifically in the areas of cultural appropriation and stereotyping. These areas involve an inbuilt power dynamic that can create harm in the communities affected including contributing to inaccurate information, discrimination, harassment and abuse.

Representing and interpreting cultural material that doesn't belong to an artist also diverts benefits (such as payment and credit) away from the cultural owners and towards the artist. Aside from the ethical implications, this can impact on the artist's reputation and professional standing in the sector. Artists may also be breaching intellectual property laws depending on the nature of the cultural material represented."

### Questions to ask include:

- Why do you feel drawn to depicting this culture?
- Are you the best person to undertake this project?
- How can you collaborate with artists from the relevant cultural group?
- Have the cultural owners given consent for this project?
- What is the level of creative control held by the cultural owners?
- Do the cultural owners have the power to say

no to this project?

- Are you sharing the benefits of the project with the relevant cultural group (including financial benefits, recognition, attribution and ongoing opportunities)?
- Are there dangers of perpetuating racial stereotypes which cause harm in the lives of real people?
- What is the impact of power in this cultural interchange?
- Could this depiction of culture be inauthentic or promote a distorted understanding of the cultural knowledge depicted?
- What potential impact does this project have on the integrity of the cultural knowledge and its communication to future generations?
- How are the cultural owners benefiting from this project?
- How are you benefiting from this project?

# Does the City provide support for access requirements?

### Does the City provide insurance for artworks?

Yes, the City covers costs for damage or theft of the artwork during the exhibition period up to the sales value nominated in the entry form. Artists are responsible for transit insurance for artworks to and from the venue.

### What awards are on offer?

All artworks are eligible for the following awards:

- Most Outstanding Artwork: \$4,000
- Highly Commended Award: \$1,500

These awards are judged by an independent panel of arts professionals

The following awards are optional based on the artist's nomination in the entry form:

• Artist in Focus Award: \$3,000 and in-kind exhibition

The Artist in Focus Award supports artistic development with a solo exhibition hosted by the City and a \$3,000 cash award. The winner of this Award must commit to an exhibition in 2024 and will receive in-kind support from the City to produce and promote the exhibition, along with a cash fee of \$3,000 towards labour, production and materials. This fee is to be managed by the Artist independently as the Artist sees fit to produce their work. Artists must provide the following:

- One page Artistic CV (PDF format)
- Up to five images of previous artworks (PDF format)
- Artist biography (maximum 300 words)

- Exhibition proposal explaining what their exhibition would be about and the artist's intention (maximum 300 words) Read more information about the Artist in Focus Award <u>here.</u>
- Celebrating Joondalup Award \$1,500

Artworks nominated for this Award will be judged in response to relating to and representing the City of Joondalup. Artists nominating for this category must provide a statement of no more than 300 words on the Entry Form. This award is restricted to artists who are residents and/or ratepayers of the City of Joondalup.

Student Award – \$750

All student entries are eligible for this award.

Popular Choice Award - \$500

The artwork that receives the most public votes during the exhibition will be awarded the Popular Choice Award of \$500 after the exhibition closes.

# Can I make changes to artwork details after submitting an entry form?

No, due to the number of artworks, changes to artworks are not permitted after the entry form submission. Artists should submit the entry form with a completed artwork.

# I didn't finish my artwork, can I receive a refund for the entry fee?

Refunds are not permitted.

# I did not deliver my artwork on time, can it still be included later?

All artworks must be received during the delivery time of 10.00am – 1.00pm, **Sunday 19 March 2023**. Due to the installation taking place on the same day, any artworks delivered late will not be included in the exhibition. Artists are recommended to contact the City's Visual Arts Team (details below) for exceptional circumstances on the date of delivery.

# I'm unable to collect my artwork on time, what should I do?

Artists should note that the City is unable to store artworks after the collection period and close of the exhibition. If artists are unable to collect artworks they should arrange for a suitable person to collect on their behalf and notify the City in advance, approving the alternate collection person in writing. Artists are recommended to contact the City's Visual Arts Team (details below) for exceptional circumstances on the date of collection.

### I have further questions

The City is hosting two free <u>information sessions</u> for those interested in exhibiting. This is the chance to hear more about the exhibition and awards, how to submit an online entry and tips for exhibiting artists. Attendees will also be able to complete an online entry at the end of the session with the City's Visual Arts Team. Registration is required.
